

Budget Engagement Commission Special Meeting Minutes

Wednesday, March 27, 2019 at 5:00 pm Mayor Ceremonial Room

Public Comments

Al Zelinka, City Manager, thanked the Budget Engagement Commission for their role in providing guidance to the City Council and public in regards to the City's financial process and Measure Z.

Approval of Minutes

No discussion. A motion was made by Commissioner Arballo and seconded by Commissioner Segura to approve the Budget Engagement Commission Meeting Minutes from Thursday, February 28, 2019.

Measure Z – Reallocate Measure Z in the amount of \$426,454 from Youth Innovation Center Capital Project Account to First Year (Fiscal Year 2019-2020) Arlington Park Youth Innovation Center Operating Costs.

Following discussion, a motion was made by Commissioner Hart and seconded by Commissioner Arballo that the Budget Engagement Commission recommend to City Council to reallocate \$426,454 from Capital to Operating for Youth Innovation Center.

Supplemental Appropriation of up to \$3,451,126 from the unallocated Measure Z Fund Balance to fund the Public Safety and Engagement Team Program

Following discussion, a motion was made by Vice Chair Fine and seconded by Commissioner Mathis that the Budget Engagement Commission recommend that the City Council approve an allocation of Measure Z funding for the expansion of mental health services by adding 28 beds in partnership with a non-profit provider (Helping Hands) to the Hulen Place Campus (Option D).

Additionally, a motion was made by Commissioner Fine and seconded by Commissioner Mayes that the Budget Engagement Commission recommend that the City Council approve an allocation of Measure Z funding of up to \$7.5 million for a maximum of 36 months to fund two Public Safety and Engagement Teams (including personnel, equipment, and training) and contract out Homeless encampment cleanup services (Option C).
