ORDINANCE NO.

AN ORDINANCE OF THE CITY OF RIVERSIDE, CALIFORNIA, AMENDING THE ZONING MAP OF THE CITY OF RIVERSIDE PURSUANT TO CHAPTER 19.090 OF THE RIVERSIDE MUNICIPAL CODE BY REZONING THE VACANT LAND KNOWN AS THE EXCHANGE PROJECT, FROM R-1-7000 - SINGLE FAMILY RESIDENTIAL ZONE, R-3-1500 - MULTI-FAMILY RESIDENTIAL ZONE, AND R-1-7000-WC – SINGLE FAMILY RESIDENTIAL – WATERCOURSE OVERLAY ZONES TO MU-U - MIXED USE URBAN ZONE AND CR -COMMERCIAL RETAIL ZONE.

The City Council of the City of Riverside, California, does ordain as follows:

Section 1: Pursuant to Chapter 19.090 of the Riverside Municipal Code, the Zoning Map of the City of Riverside is hereby amended by rezoning the vacant land known as the Exchange Project, from the R-1-7000 – Single Family Residential Zone, R-3-1500 – Multi-Family Residential Zone, and R-1-7000-WC – Single Family Residential – Watercourse Overlay Zones to the MU-U – Mixed Use Urban Zone and to the CR – Commercial Retail Zone, all the properties described and depicted in Exhibit "A" attached hereto and incorporated herein by reference, subject to all of the conditions, restrictions and covenants imposed under Planning Case No. P18-0092, which conditions, restrictions and covenants are incorporated herein by reference.
