1	ORDINANCE NO.
2 3	AN ORDINANCE OF THE CITY OF RIVERSIDE, CALIFORNIA, AMENDING SECTION 1.15.040 OF THE RIVERSIDE MUNICIPAL CODE PROVIDING FOR MAYORAL REGULAR MUNICIPAL
4	ELECTIONS TO BE CONSOLIDATED WITH THE STATEWIDE ELECTIONS OF THE UNITED STATES PRESIDENT BEGINNING IN 2020.

6	The City Council of the City of Riverside does ordain as follows:
7	Section 1: Section 1.15.040 of the Riverside Municipal Code is hereby amended to add
8	the following new subsection "E" as follows:
9	"E. Beginning in 2020, general municipal elections for the election of the Mayor shall be
10	held in the City on the same day as the statewide election, consistent with the primary and
11	general election dates set by the State for the election of the President of the United States of
12	America."
13	Section 2: The City Council has reviewed the matter and, based upon the facts and
14	information contained in the staff reports, administrative record, and written and oral testimony,
15	hereby finds that this ordinance is not subject to CEQA pursuant to Sections 15060(c)(2),
16	15060(c)(3) and/or 15061(b)(3) of the State CEQA Guidelines, California Code of Regulations, Title
17	14, Chapter 3, in that it will not result in a direct or reasonably foreseeable indirect physical change
18	in the environment nor have a significant impact on the environment.
19	Section 3: The City Clerk shall certify to the adoption of this ordinance and cause
20	publication once in a newspaper of general circulation in accordance with Section 414 of the Charter
21	of the City of Riverside. This ordinance shall become effective on the 30th day after the date of its
22	adoption.
