## THIRD AMENDMENT TO LEASE AGREEMENT

THIS THIRD AMENDMENT TO LEASE	E AGREEMENT ("Third Amendment") is made

the CITY OF RIVERSIDE, a California charter	
AMERICAN YOUTH SOCCER ORGANIZAT	TION - REGION 47, a California non-profit
corporation ("Lessee"), with respect to the following facts:	

## RECITALS

WHEREAS, on or about May 26, 2015, City and Lessee entered into a Lease Agreement ("Lease") for a 56.01 acre site on Placentia Lane, generally east of North Main Street and north of Columbia Avenue, Riverside California ("Property"). The Property is being used by Lessee as a soccer athletic facility known as the AB Brown Complex; and

WHEREAS, on or about June 13, 2016, City and Lessee entered into a First Amendment to Lease Agreement extending the term by two years ("First Amendment"); and

WHEREAS, on or about July 11, 2018, City and Lessee entered into a Second Amendment to Lease Agreement ("Second Amendment") extending the term by one year until June 30, 2019, and providing that Lessee shall have an option to extend the term of the Lease for two (2) additional one-year periods and that Lessee may exercise such options by (i) sending a written request to the City at least one hundred twenty (120) days prior to the expiration of the then-current term of the Lease; (ii) providing an accounting of all other use of the Property by non-AYSO entities during the preceding year of the Lease; and (iii) providing an accounting of all funds collected by AYSO from non-AYSO entities for use of the Property during the preceding year of the Lease; and

WHEREAS, Lease will expire on June 30, 2019; and

WHEREAS, Lessee has (i) sent a written request to the City at least one hundred twenty (120) days prior to June 30, 2019; (ii) provided an accounting of all other use of the Property by non-AYSO entities during the preceding year of the Lease; and (iii) provided an accounting of all funds collected by AYSO from non-AYSO entities for use of the Property during the preceding year of the Lease; and

WHEREAS, City and Lessee now desire extend the term of the Lease by one year, to June 30, 2020.

NOW, THEREFORE, in consideration of the foregoing recitals, which are incorporated herein by this reference, City and Lessee agree as follows:

- 1. The term of the Lease is hereby extended by one year, until June 30, 2020. .
- 2. Compensation for the extended term of the Lease shall be Twelve Thousand Dollars (\$12,000) annually.

3. All terms and conditions of the Lease, and the First and Second Amendments thereto, not inconsistent with this Third Amendment, shall remain in full force and effect, and are incorporated herein by this reference as if set forth in full.
