

1 RESOLUTION NO.

2 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF  
3 RIVERSIDE, CALIFORNIA, APPROVING THE APPLICATION  
4 FOR STATEWIDE PARK DEVELOPMENT AND COMMUNITY  
REVITALIZATION PROGRAM GRANT FUNDS FOR LOW PARK  
MASTER PLAN IMPROVEMENTS.

5 WHEREAS, the State Department of Parks and Recreation has been delegated the  
6 responsibility by the Legislature of the State of California for the administration of the Statewide  
7 Park Development and Community Revitalization Grant Program, setting up necessary procedures  
8 governing the application; and

9 WHEREAS, said procedures established by the State Department of Parks and Recreation  
10 require the Applicant to certify by resolution the approval of the application before submission of  
11 said application to the State; and

12 WHEREAS, successful Applicants will enter into a contract with the State of California to  
13 complete the Grant Scope project.

14 NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside,  
15 California, as follows:

16 Section 1: The City Council hereby approves the filing of an application for the Low  
17 Park Master Plan Improvement.

18 Section 2: The City Council hereby certifies that said Applicant has or will have  
19 available, prior to commencement of any work on the project included in the application, the  
20 sufficient funds to complete the project.

21 Section 3: The City Council hereby certifies that if the project is awarded, the Applicant  
22 has or will have sufficient funds to operate and maintain the project.

23 Section 4: The City Council hereby certifies that the Applicant has reviewed,  
24 understands, and agrees to the General Provisions contained in the contract shown in the Grant  
25 Administration Guide.

26 Section 5: The City Council hereby delegates the authority to the City Manager to  
27 conduct all negotiations, sign and submit all documents, including, but not limited to applications,

1 agreements, amendments, and payment requests, which may be necessary for the completion of the  
2 Grant Scope.

3 Section 6: The City Council hereby agrees to comply with all applicable federal, state  
4 and local laws, ordinances, rules, regulations and guidelines.

5 Section 7: The City Council hereby will consider promoting inclusion per Public  
6 Resources Code § 80001(b)(8A – G).
