PARK DEVELOPMENT AND COMMUNITY REVITALIZATION PROGRAM

1. Park Development and Revitalization Program is funded through California Drought, Water, Parks, Climate, Coastal Protection and Outdoor Access for All Act of 2018;
2. Goal is to Create new parks and recreation opportunities in underserved communities; and
3. Parks were selected based off eligibility criteria of having 3 acres or less of parkland per 1,000 residents or a median income of \$51,026 within a half mile radius of park site.

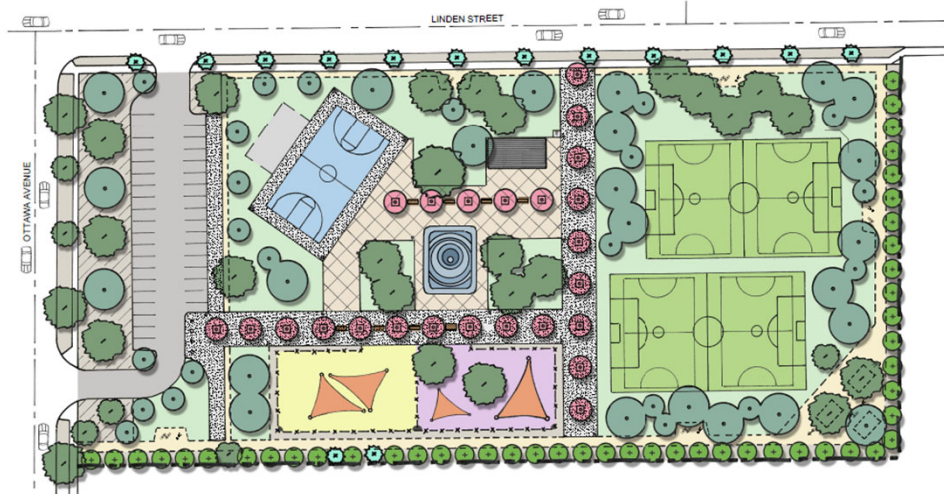

RECOMMENDATIONS

That the City Council:

1. Adopt the attached resolutions approving the applications for the Statewide Park Development and Community Revitalization Program grant application for Low Park, Myra Linn Park and Patterson Park;
2. Upon grant award, authorize the Chief Financial Officer, or his designee, to record and increase revenues in the amount of \$5,005,000 or the actual amount awarded, and appropriate expenditures in the same amount to the Low Park Development & Revitalization Program account 9339600 following the receipt of the grant award;

RECOMMENDATIONS

3. Upon grant award, authorize the Chief Financial Officer, or his designee, to record and increase revenues in the amount of \$8,500,000 or the actual amount awarded, and appropriate expenditures in the same amount to the Myra Linn Park Development and Revitalization Program account 9339800 following the receipt of the grant;
4. Upon grant award, authorize the Chief Financial Officer, or his designee, to record and increase revenues in the amount of \$7,150,000 or the actual amount awarded, and appropriate expenditures in the same amount to the Patterson Park Development and Revitalization Program account 9339700 following the receipt of the grant; and
