A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, RECITING THE FACT OF THE GENERAL MUNICIPAL ELECTION HELD IN SAID CITY ON THE 4TH DAY OF JUNE, 2019, DECLARING THE RESULTS THEREOF AND SETTING FORTH SUCH OTHER MATTERS AS ARE PROVIDED BY LAW.

WHEREAS, a General Municipal Election was held and conducted in the City of Riverside on the 4th day of June, 2019, as required by law for the purpose of electing members of the City Council for Wards 1, 3, 5, and 7; and

WHEREAS, notice of said election was duly and regularly given in the time, form and manner as provided by law; and in all respects said election was held and the returns made and declared in the time, form, and manner as required by the provisions of the Charter of the City of Riverside and the Elections Code of the State of California for the holding of elections in the City of Riverside; and

WHEREAS, pursuant to Resolution No. 23413 adopted on the 22nd day of January, 2019, the appropriate County official canvassed the returns of said election and has certified the results to this City Council and said results are received, attached, and made a part hereof as Exhibit "A".

NOW THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside, as follows:

<u>Section 1:</u> That there were ____ voting precincts in the First Ward; ____ voting precincts in the Third Ward; ____ voting precincts in the Fifth Ward, and ____ voting precincts in the Seventh Ward.

Section 2: That said General Municipal election was held for the purpose of electing four (4) members of the City Council of the City of Riverside from Wards 1, 3, 5, and 7 of the City of Riverside as established by the City Council.

<u>Section 3</u>: That all voter ballots were cast by mail in the City of Riverside; that the whole number of votes cast in the First Ward in the City of Riverside was ____; that the whole number of votes cast in the Third Ward in the City of Riverside was ____; that the whole number of votes

Section 5: The City Council does declare and determine that in the First Ward no candidate received a majority of the votes cast. That candidate Erin Edwards received the highest and candidate Mike Gardner the next highest number of votes cast for Member of the City Council of the First Ward. That pursuant to Section 400 of the Charter of the City of Riverside, the City Council shall call a Special Election to be held on November 5, 2019, at which time the names of these candidates shall appear on the ballot, to wit:

ERIN EDWARDS

for Member of City Council

MIKE GARDNER

for Member of City Council

and the candidate receiving the highest number of votes at said Special Election for the abovenamed office shall be elected Councilmember from Ward One.

Section 6: The City Council does declare and determine that in the Third Ward no candidate received a majority of the votes cast. That candidate Ronaldo Fierro received the highest and candidate Warren Avery the next highest number of votes cast for Member of the City Council of the Third Ward. That pursuant to Section 400 of the Charter of the City of Riverside, the City Council shall call a Special Election to be held on November 5, 2019, at which time the names of these candidates shall appear on the ballot, to wit:

RONALDO FIERRO

for Member of City Council

WARREN AVERY

for Member of City Council

and the candidate receiving the highest number of votes at said Special Election for the abovenamed office shall be elected Councilmember from Ward Three.

Section 7: The City Council does declare and determine that in the Fifth Ward no candidate received a majority of the votes cast. That candidate Sean Mill received the highest and candidate Gabriella Plascencia the next highest number of votes cast for Member of the City Council of the Fifth Ward. That pursuant to Section 400 of the Charter of the City of Riverside,

the City Council shall call a Special Election to be held on November 5, 2019, at which time the names of these candidates shall appear on the ballot, to wit:

for Member of City Council

GABY PLASCENCIA

for Member of City Council

and the candidate receiving the highest number of votes at said Special Election for the abovenamed office shall be elected Councilmember from Ward Five.

Section 8: The City Council does declare and determine that in the Seventh Ward no candidate received a majority of the votes cast. That candidate Steve Hemenway received the highest and candidate William D. Pearce the next highest number of votes cast for Member of the City Council of the Seventh Ward. That pursuant to Section 400 of the Charter of the City of Riverside, the City Council shall call a Special Election to be held on November 5, 2019, at which time the names of these candidates shall appear on the ballot, to wit:

STEVE HEMENWAY

for Member of City Council

WILLIAM D. PEARCE

for Member of City Council

and the candidate receiving the highest number of votes at said Special Election for the abovenamed office shall be elected Councilmember from Ward Seven.

<u>Section 9:</u> That the City Clerk shall enter on the records of the City Council of said City a statement of the results of the General Municipal election held on June 4, 2019, showing:

- (1) The whole number of votes cast in the First, Third, Fifth, and Seventh Wards of said City;
- (2) The names of the persons voted for;
- (3) The office each person was voted for;
- (4) The number of votes given at each precinct to each of said persons; and
- (5) The number of votes given in the First, Third, Fifth, and Seventh Wards of said City to each of person running for member of City Council.
