### **7. UPDATE ON THE STATE OF CALIFORNIA PROPOSITION 68 FUNDS**

Director Cruz introduced Gabriella Garcia, Senior Management Analyst, and Jordan Maus, Project Manager; they have been leading the Department on grants available through Proposition 68. They will be providing an update on the Statewide Park Development and Community Revitalization Program.

Senior Management Analyst Garcia presented on the application process and partnerships developed.

Project Manager Maus presented on the community input process and the conceptual designs created for Low, Myra Linn, and Patterson Parks.

Commissioner Whatley inquired on acres for each park, asked if the grant will cover the cost of all the improvements, and when will the report be taken to City Council.

Project Manager Maus confirmed the grant will cover all costs for the improvements and report will be taken to City Council July 2, 2019. Application will be submitted by August 5 for each park.

Commissioner Cardullo inquired when the City will hear on status of the application process.

Senior Management Analyst Garcia mentioned Department will hear back by late winter 2019

on park selection.
