13	thereby adopting the Master Fringe Benefits and Salary Plan ("FBSP"); and			
14	WHEREAS, the FBSP includes the fringe benefits and salary plans for City employees;			
15	and			
16	WHEREAS, the FBSP has been amended several times to update the benefits and			
17	salaries; and			
18	WHEREAS, the Job Code Table of the FBSP needs to be revised to reflect the additional			
19	pay language for the Deputy General Manager for Riverside Public Utilities; and			
20	WHEREAS, the Job Code Table of the FBSP needs to be revised to reflect the new			
21	classifications and salary ranges for the existing Senior Mini-Bus Driver/Dispatcher-Scheduler,			
22	Payroll Supervisor, Payroll Technician I and II; and			
23	WHEREAS, the Job Code Table of the FBSP needs to be revised to reflect the title			
24	change for the Deputy Community Development Director; and			
25	WHEREAS, the Job Code Table of the FBSP needs to be revised to reflect the title			
26	change and salary range adjustment for the Innovation Security Officer; and

WHEREAS, the Job Code Table of the FBSP needs to be revised to reflect the salary
 adjustments to the Senior Code Enforcement Officer, Fleet Operations Manager, and Weekend
 Crew Supervisor classifications; and

WHEREAS, the Job Code Table of the FBSP needs to be revised to reflect the modification of the salary step structure for the Wastewater Maintenance Mechanic classification; and

WHEREAS, miscellaneous language clean-up corrections need to be made to the FBSP.

Resolution No. 21052 and the Master Fringe Benefits and Salary Plan are Section 1: 10 hereby amended to 1) add additional pay language for the assignment of Deputy General 11 Manager for the Riverside Public Utilities; 2) create the classifications and salary ranges for 12 Senior Mini-Bus Driver/Dispatcher-Scheduler, Payroll Supervisor, Payroll Technician I and II; 13 3) change the title of Deputy Community Development Director; 4) change the title and salary 14 range for the Innovation Security Officer; 5) adjust the salary ranges for the existing Senior Code 15 Enforcement Officer, Fleet Operations Manager, and Weekend Crew Supervisor classifications; 16 6) modify the salary step structure for the Wastewater Maintenance Mechanic classification; and 17 7) approve miscellaneous language clean-up to include corrections under part I, section 22, 18 retirement contribution, table 12 and part II, section 5, salary differentials, item (I)(1) 19 miscellaneous, all as set forth in Exhibit "A" attached hereto and incorporated herein by 20 reference. 21

 procedures or documents necessary to implement these provisions.
