BACKGROUND

- 1. October 18, 2013 Board approved Phase 1 of Streetlight Replacement Project
- 2. February 13, 2017 Board approved Phase 2
- 3. This project is the third of five (5) phases
- 4. New streetlight standard is replica of original historic standard with acorn style luminaire
- 5. New streetlight standard features energy efficient LED (Light Emitting Diode) lamps

AGING INFRASTRUCTURE

- 1. 100 year old streetlight system is deteriorating and cables are failing, creating maintenance and safety issues
- Replacement of aged underground infrastructure is identified as priority in Utility 2.0 Electric Infrastructure Road Map



PROJECT LOCATION

- 1. Wood Streets Phase 3 area, north of Fourteenth Street, south of Mission Inn Avenue, west of Market Street, east of Redwood Drive, and along Larchwood Place between Palm Avenue and Brockton Avenue
- 2. Project will upgrade 129 streetlight standards

SCOPE OF WORK

- Replacement of 129 streetlight standards with new concrete streetlight standards and paving
- 2. Install 16,000 feet of conduit
- 3. Install 18,400 circuit feet of secondary underground cable
- 4. 18 weeks to complete work

CULTURAL HERITAGE BOARD

November 21, 2018 - Cultural Heritage Board recommended that City Council:

- 1. Determine Planning Case P18-0585 will not have significant effect on environment as it relates to historic resources
- 2. Adopt Mitigated Negative Declaration
- 3. Approve Case, based on findings thereby issuing a Certificate of Appropriateness for Streetlight Replacement Areas 3 to 5B with condition that light color temperature for luminaires shall be 2,200 Kelvins to retain historically appropriate light color warmth
