SUBJECT: POLICE DEPARTMENT ASSET FORFEITURE FUNDS – FUNDS TRANSFER AND SUPPLEMENTAL APPROPRIATION IN THE AMOUNT OF \$772,062

ISSUE:

Authorize a supplemental appropriation of asset forfeiture funds in the amount of \$772,062 from the Federal Asset Forfeiture Account, Federal Treasury Asset Forfeiture Account and State Asset Forfeiture Account to a Grants and Restricted Programs Fund Police Department revenue account and appropriate expenditures in the same amount to the Grants and Restricted Programs Fund Police Department expenditure accounts as detailed in this report.

RECOMMENDATION:

That the City Council authorize a supplemental appropriation of asset forfeiture funds in the amount of \$772,062 from Police Department deposit accounts including \$487,196 from the Federal Asset Forfeiture Account, \$211,866 from the Federal Treasury Asset Forfeiture Account, and \$73,000 from the State Asset Forfeiture Account to a Grants and Restricted Programs Fund Police Department revenue account and appropriate expenditures in the same amount to the Grants and Restricted Programs Fund Police Department expenditure accounts as detailed in this report.

BACKGROUND:

Federal and State legislation allow for funds seized by law enforcement during the investigation of specific narcotics law violations to be forfeited to the investigating law enforcement organizations. These funds are restricted in use to law enforcement and must be used to supplement, not supplant, the Police Department's annual budget.

DISCUSSION

The proposed expenditures for the asset forfeiture funds include equipment, supplies and services that help support the City's law enforcement operations. The items and services requested this year include software, technology upgrades, building improvements, ammunition, weapons, training and surveillance equipment, and a Bearcat vehicle.

FISCAL IMPACT:

The total asset forfeiture funding requested totals \$772,062 and will be used to purchase equipment, supplies and services in support of law enforcement operations.

Upon approval a supplemental appropriation in the amount of \$772,062 including \$487,196 from the Federal Asset Forfeiture Account No. 0000721-225111, \$211,866 from the Federal Treasury Asset Forfeiture Account No. 0000721-225112, and \$73,000 from the State Asset Forfeiture Account No. 0000721-225112, and \$73,000 from the State Asset Forfeiture Account No. 0000721-225110 will be transferred to the Grants and Restricted Programs Fund Police Department revenue account numbers, 3145201-374500, 3145401-374500, 3145501-374500 respectively, and appropriate expenditures in the same amount to the Police Department Expenditure accounts as detailed in the chart below.
