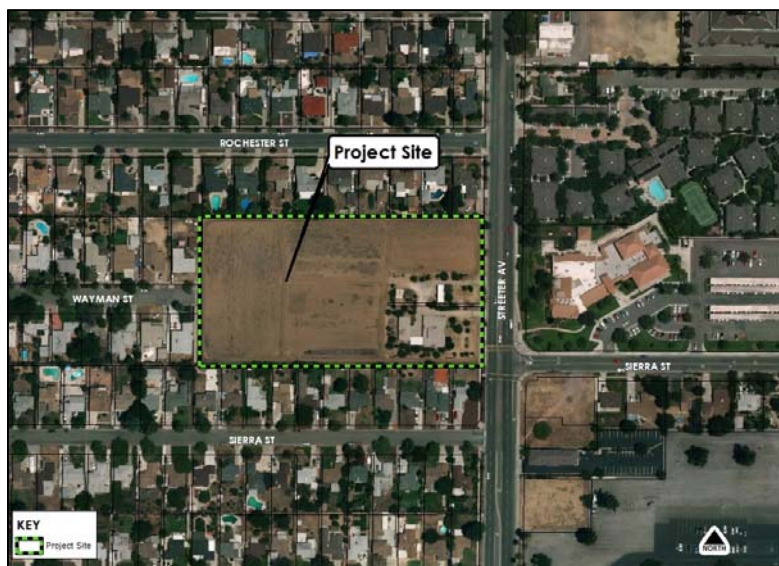

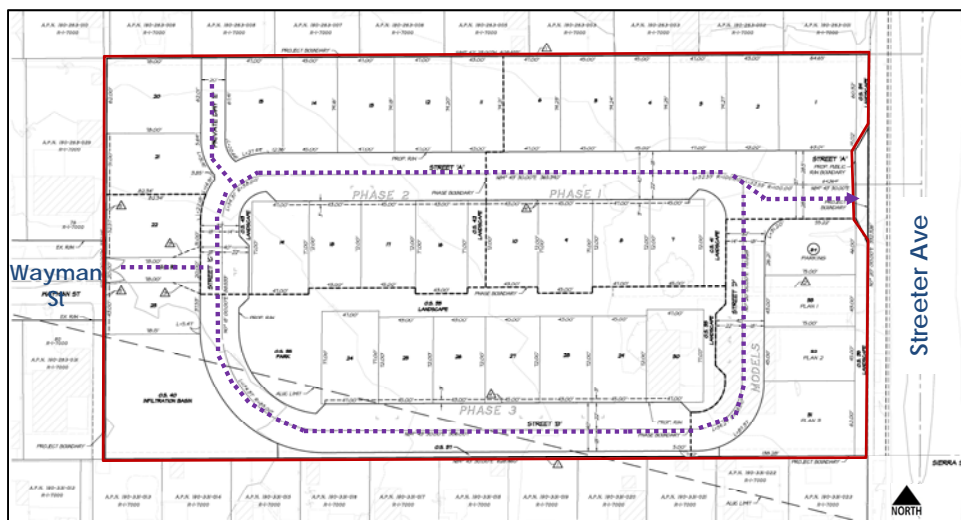

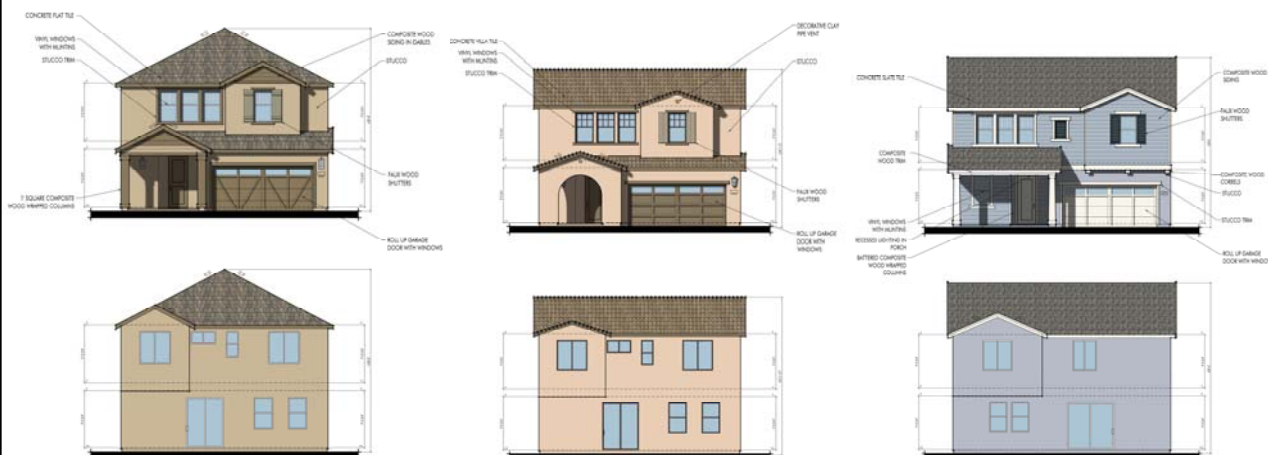

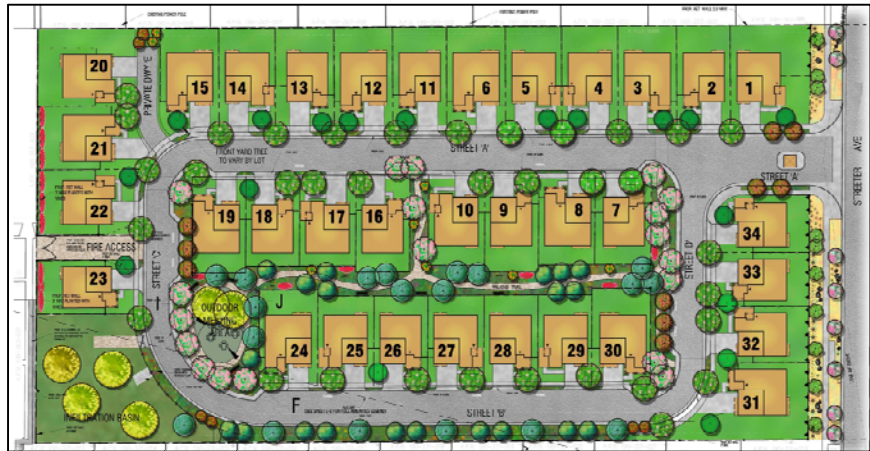

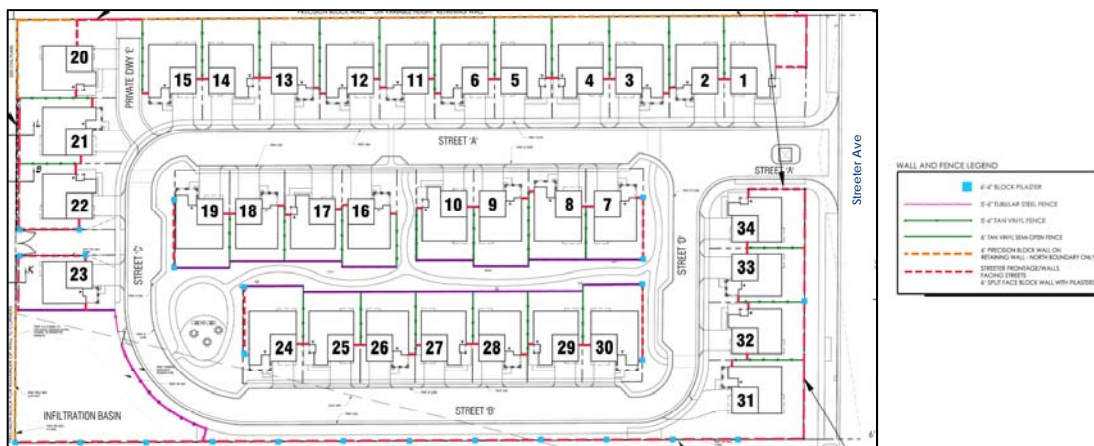

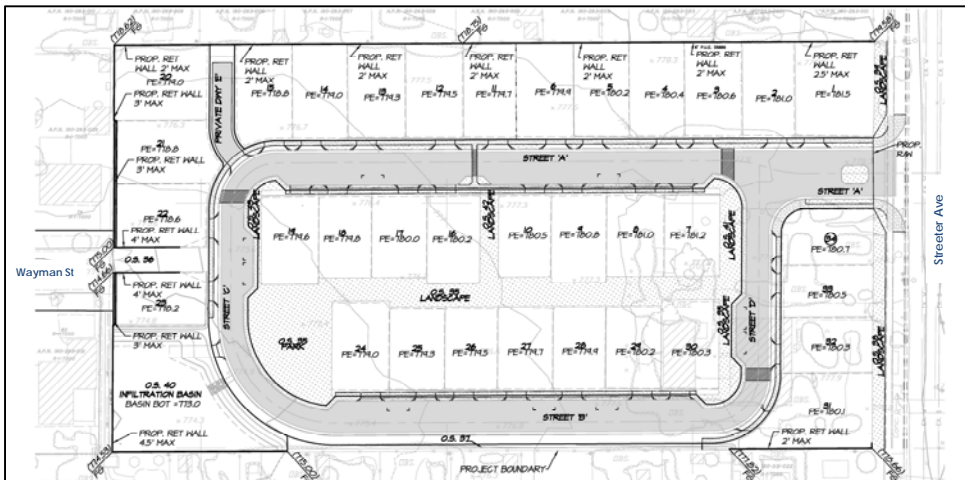

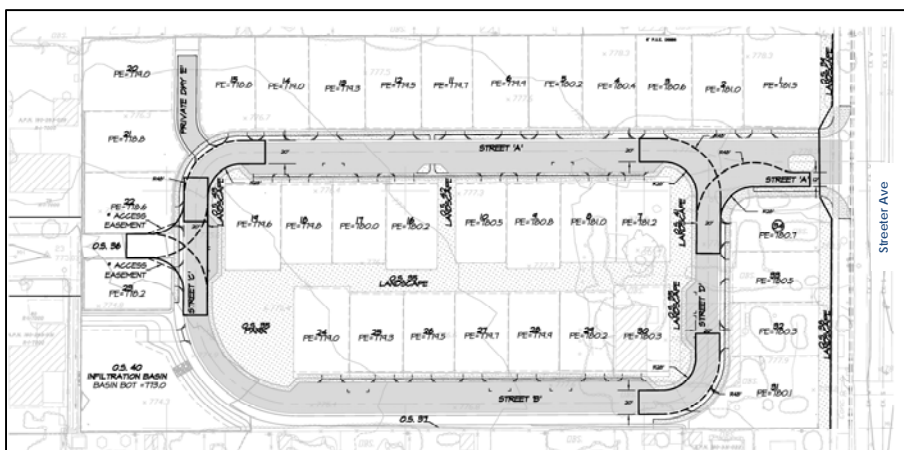

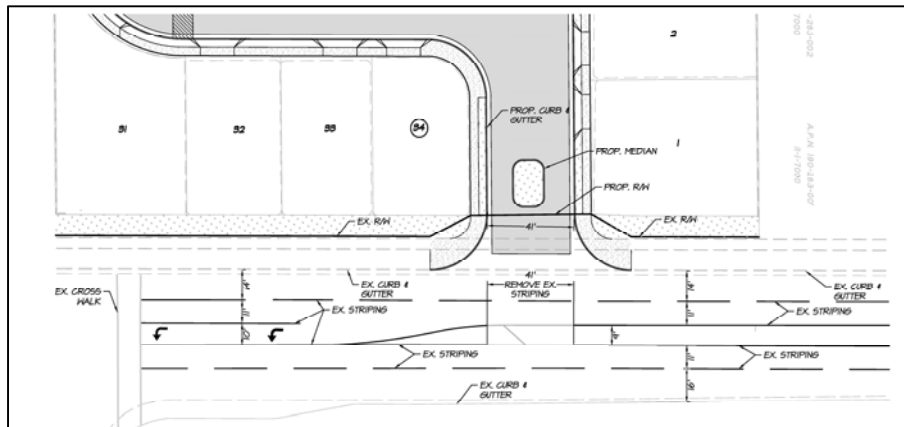

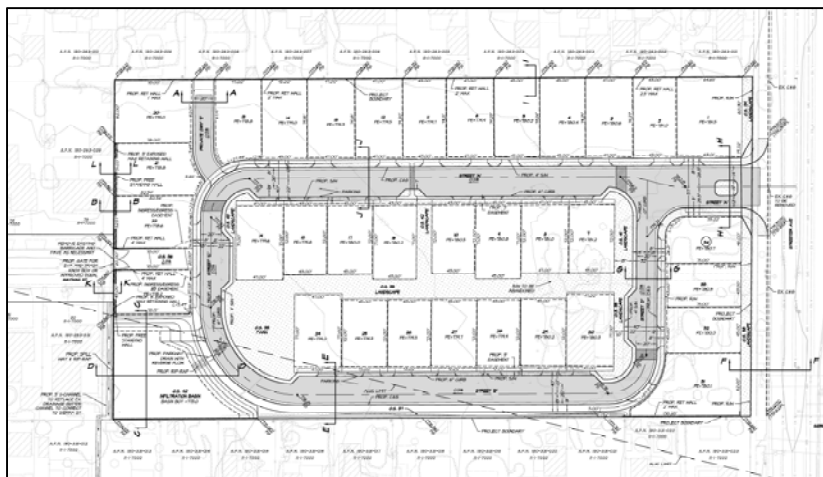

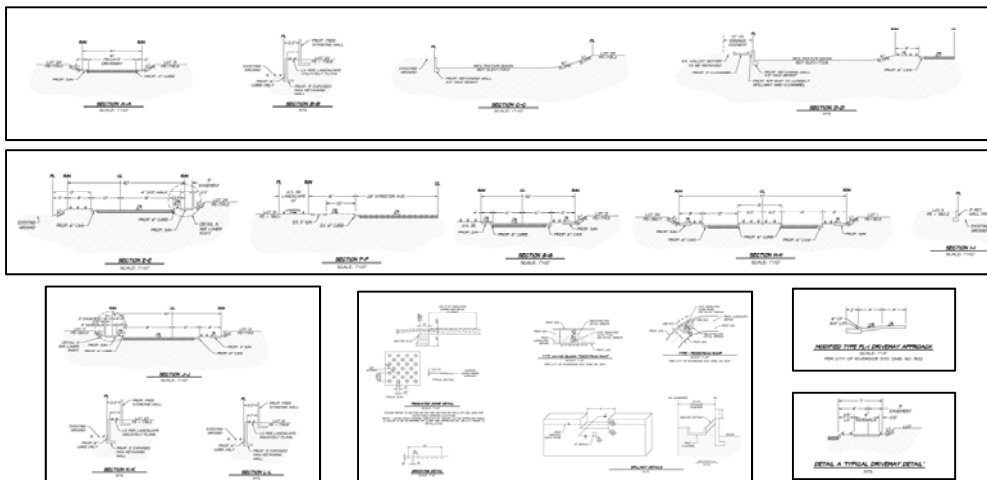
CONCEPTUAL GRADING PLAN (REFERENCE ONLY)

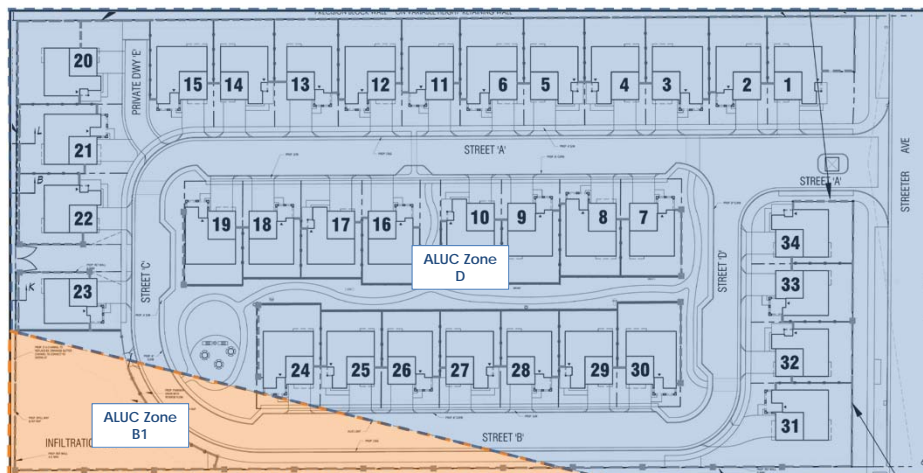
