A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, AUTHORIZING APPLICATION FOR, AND RECEIPT OF, SB 2 PLANNING GRANTS PROGRAM FUNDS

WHEREAS, the Department of Housing and Community Development for the State of 5 California ("Department") is authorized to provide up to One Hundred Twenty Three Million 6 Dollars (\$123,000,000) under the SB 2 Planning Grants Program ("PGP") from the Building 7 Homes and Jobs Trust Fund to assist cities with activities that accelerate housing production, as 8 set forth in California Health & Safety Code § 50470 et seq. (Chapter 364, Statutes of 2017 [SB 9 2]); and 10

WHEREAS, the Department has issued a Notice of Funding Availability ("NOFA"), 11 dated March 28, 2019, for its PGP; and 12

WHEREAS, the City of Riverside ("City") desires to submit a project application for 13 the PGP to accelerate the production of housing and will submit a 2019 PGP grant application 14 as described in the NOFA and SB 2 Planning Grants Program Guidelines released by the 15 Department for its PGP. 16

NOW, THEREFORE, THE CITY COUNCIL FOR THE CITY OF RIVERSIDE 17 **RESOLVES AS FOLLOWS:** 18

<u>Section 1</u>: The City Manager, or his designee, is authorized to submit to the Department 19 an application for PGP funds in accordance with the 2019 SB 2 Planning Grant Program Application issued on March 28, 2019, in an amount not to exceed Six Hundred Twenty Five Thousand Dollars (\$625,000), and if awarded, to accept the award and to use such funds for 22 eligible activities in the manner presented in the grant application, as approved by the 23 Department and in accordance with the SB 2 Planning Grant Program Guidelines issued by the Department. 25

Section 2: In connection with the PGP grant, if the application is approved by the 26 Department, the City Manager, or his designee, is authorized to negotiate, enter into, execute, 27 and deliver a State of California Agreement ("Standard Agreement") in an amount not to exceed 28

Six Hundred Twenty Five Thousand Dollars (\$625,000) and any and all other documents deemed necessary or appropriate to evidence and secure the PGP grant or fulfill the City's obligations related thereto, as well as amendments thereto (collectively, the "PGP Grant Documents").

Section 3: The City understands and acknowledges that the City shall be subject to the terms and conditions as specified in the Standard Agreement, the SB 2 Planning Grants Program Guidelines, and any applicable PGP guidelines published by the Department; funds are to be used for allowable expenditures as specifically identified in the Standard Agreement; the application in full is incorporated as part of the Standard Agreement; and any and all activities funded, information provided, and timelines represented in the application will be enforceable through the executed Standard Agreement.

<u>Section 4</u>: The City hereby agrees to use the funds for eligible uses in the manner presented in the application as approved by the Department and in accordance with the NOFA, the Planning Grants Program Guidelines, and 2019 Planning Grants Program Application.

Section 5: The City Manager, or his designee, is authorized to execute the City of Riverside Planning Grants Program Application, the PGP Grant Documents, and any amendments thereto, on behalf of the City of Riverside as required by the Department for acceptance and receipt of the PGP Grant.
