### **BACKGROUND**





Senate Bill 2 (SB 2):

- 1. 2017 Building Homes and Jobs Act
- 2. Imposes fee on recordation of real estate documents
- 3. Permanent source of affordable housing funds
- 4. 50% of first year funds (2018) to update planning documents





#### **BACKGROUND**



- Community Development (HCD)
- b) Over the counter grant
- 2. Riverside eligible for \$625,000:
  - a) Non-competitive
  - b) Funded projects must be completed by June 30, 2022
  - c) Application due by November 30, 2019

## **BACKGROUND**

- 1. Grant Objectives:
  - a) Must accelerate housing production
  - b) Update planning documents, environmental analysis or expedited processes
- 2. City Application Proposal:
  - a) Streamlining program with nine (9) potential projects
  - b) \$1,290,000 estimated project cost
  - c) Vetted through HCD's technical assistance program






- 4. Community Revitalization and Investment Authority (CRIA)









- Adopt a Resolution authorizing the City Manager, or designee, to submit a grant application to the California Department of Housing and Community Development for up to \$625,000 as part of the Senate Bill 2 Grant Program;
