1	AN ORDINANCE OF THE CITY OF RIVERSIDE, CALIFORNIA,
2	AMENDING CHAPTER 9.70 OF THE RIVERSIDE MUNICIPAL CODE ENTITLED ECOATM MACHINES AND OTHER SIMILAR DEVICES OR
3	MACHINES.
4	The City Council of the City of Riverside does ordain as follows:
5	Section 1: The Table of Contents of Chapter 9.70 entitled EcoATM Machines and Other
6	Similar Devices or Machines is hereby amended as follows:
7	"Chapter 9.70
8	ECOATM MACHINES AND OTHER SIMILAR DEVICES OR MACHINES
9	Sections:
10	9.70.010 Findings. EcoATM machines and other similar kiosk machines.
11	9.70.020 Authority and purpose.
12	9.70.030 Definitions." 9.70.040 EcoATM machines and other similar machines prohibited.
13	
14	Section 2: Section 9.70.10 of the Riverside Municipal Code formerly entitled "Findings"
15	and is now entitled "EcoATM machines and other similar kiosk machines" and is hereby repealed in
16	its entirety and replaced with the following:
17	"The City Council finds as follows:
	A. EcoATM is a kiosk machine that allows people to sell their cell phones, mp3 players, and
18	tablets in exchange for an immediate cash distribution or charitable donation.
19	B. EcoATM employs security features to both deter and catch thieves selling stolen devices.
20	C. EcoATM requires the consumer to swipe a valid government issued ID, provide a valid
21	thumbprint, and allow the machine to take their photograph. Whenever "technically possible"
22	EcoATM also logs the serial number of each personal electronic device involved in a transaction.
23	D. EcoATM machines are responsible for a rise in violent and non-violent theft of personal
24	electronic devices in cities permitting the machines, such as Washington D.C., El Cajon, Glendale and
25	San Diego. Examples of such incidents include the following:
26	
27	1. In March of 2013, the Washington D.C. police reported that 40 percent of all forced robberies
28	in the last year involved a cell phone. In a recent investigation, the D.C. police discovered six stolen

cell phones inside ecoATM machines. The Police have even video recorded thieves using an elderly woman as a middleman to complete the ecoATM transaction.

2. In April 2013, El Cajon Police expressed concern about ecoATM machines contributing to the rise in cell phone theft. Two teenagers, ages 14 and 15, were arrested for six cell phone thefts in which the teenagers sold the phones to ecoATM machines for quick cash.

3. San Diego Police also reported a marketed rise in cell phone theft since the installation of ecoATMs. From January 2011 to March 2013, there were 270 cell phone thefts on the streets of the City and some of the stolen phones were later found inside ecoATM machines.

4. In May of 2013, news anchors Jeff Rossen and Avni Patel from the Today Show on NBC tested the security features of ecoATM in one of their "Rossen Reports" specials. The reporters sent two NBC producers to two different ecoATM machines and told them to switch IDs. Although the producer looked nothing like the picture in the ID, both ecoATM machines approved the transaction and dispensed cash for the deposited phone.

5. In July of 2013, Glendale Police reported several instances where juvenile suspects sold stolen devices to an ecoATM machine using the identification of others (adults) that looked nothing like the person using the machine. The stolen devices had already been exchanged for cash by the time the devices were reported stolen to the police.

E. EcoATM's security features cannot successfully deter thieves; the machine does not does not have the technology to verify whether the valid government issued ID, fingerprint, and photograph collected by the machine belong to the person completing the transaction and whether the person is the true owner of the device being sold.

F. There is no security device that ecoATM could install to catch thieves who use third parties or
"middlemen" to complete the transaction.

G. Theft of personal electronic devices is already a growing problem in the City of Riverside even without the addition of ecoATM machines. On April 4, 2013, the University of California Riverside held a town meeting to discuss campus safety and the rise in cell phone theft.

H. Currently, there are no ecoATM locations in the City of Riverside. It is reasonable to conclude
 that the adverse effects of ecoATM machines on the public health, safety, and welfare of other cities
 will certainly occur in the City of Riverside if the City fails to prohibit the machines. The incentive

that these machines create far outweighs the benefits derived from their security features. The securityfeatures of the ecoATM machines fail to deter and aid in prosecuting thieves. Theft of personalelectronic devices is on the rise in the City and will likely increase from the quick and easy cashincentive provided by ecoATM machines.

"EcoATM machines and other similar kiosk machines that allow people to sell their personal electronic devices in exchange for immediate cash, store credit, or charitable donation can only be operated in the City of Riverside if they are in full compliance with standard security measures required by state law, including but not limited, to Business & Professions Code Section 21628. In addition, EcoATM machines or similar kiosk machines can only be operated in the City of Riverside if they have implemented the following protocols to cooperate with the Riverside Police Department:

A. The kiosk machine must be equipped with at least three (3) built-in high definition webcams which can be accessed remotely by a live machine attendant. The cameras must take real time photographs at the time of the transaction, which must be remotely transmitted to a live online employee to manually compare each seller's photo ID with the seller's face in real-time to confirm his or her identity and to verify that the person using the kiosk machine matches the photo on the ID scan. The transaction shall be denied if:

- 1. The seller is under the age of 18,
- 2. The photo ID is expired,
- 3. The photo on the ID does not match the seller's captured real-time photograph,
- 4. The seller is not in camera view, or
- 5. The camera is blocked.
- B. The kiosk machine must be equipped with biometric devices to capture a valid fingerprint from each seller, which is recorded in the kiosk machine's database;
- C. The kiosk machine must check each mobile device's electronically embedded serial number to determine if the device had been previously reported as stolen and/or if a specific mobile device was received by a machine. The serial number of a device must be checked through a company that complies a comprehensive database of stolen devices

1	based on information from nationwide phone carriers, local law enforcement, and the
2	FBI. If the machine recognizes the mobile device as one that had been reported as stolen
3	or one where the owner of the device remotely enabled a "kill switch" to remove their
4	information from the device, the machine shall reject the transaction.
5	D. Any person or company who owns or operates a kiosk machine in the City of Riverside
6	must offer law enforcement officers access to the kiosk machine's transaction reports
7	without charge, even if it requires the owner operator of a kiosk machine to partner with a
8	company to provide such a service.
9	E. Any person or company who owns or operates a kiosk machine in the City of Riverside
10	shall not require a warrant or subpoena to provide an inventoried mobile device to law
11	enforcement;
12	F. Any person or company who owns or operates a kiosk machine in the City of Riverside
12	must respond to any law enforcement request to research and/or return reported stolen
13	mobile devices that may have been collected by the kiosk machine;
14	G. The kiosk machine must be capable of being opened remotely for law enforcement
	personnel who need access to a mobile device inside the kiosk machine;
16	H. The kiosk machine must hold all inventory collected for a minimum of 30 days; and
17	I. Any person or company who owns or operates a kiosk machine in the City of Riverside
18	must work with the Riverside Police Department to implement a "do not buy" list that
19	bans individuals from utilizing these machines."
20	Section 3: Section 9.70.040 of the Riverside Municipal Code entitled EcoATM Machines
21	and Other Similar Machines Prohibited is hereby repealed in its entirety.
22	"EcoATM machines and other similar devices or machines are prohibited in the City of
23	Riverside. No person shall locate, operate, own, suffer, allow to be operated or aide, abet or
24	assist in the operation of any EcoATM machine or other similar device or machine within the
25	City."
26	Section 4: The City Council has reviewed the matter and, based upon the facts and
27	information contained in the staff reports, administrative record, and written and oral testimony,
28	hereby finds that this ordinance is not subject to CEQA pursuant to Sections 15060(c)(2), 15060(c)(3)

1	and/or 15061(b)(3) of the State CEQA Guidelines, California Code of Regulations, Title 14, Chapter
2	3, in that it will not result in a direct or reasonably foreseeable indirect physical change in the
3	environment nor have a significant impact on the environment.
4	Section 5: The City Clerk shall certify to the adoption of this ordinance and cause
5	publication once in a newspaper of general circulation in accordance with Section 414 of the Charter
6	of the City of Riverside. This ordinance shall become effective on the 30th day after the date of its
7	adoption.
