RECITALS

WHEREAS, the City and Consultant entered into that certain Professional Consultant Services Agreement dated April 18, 2013 ("Agreement"); and

WHEREAS, the City has been satisfied with Consultant's performance under the Agreement and desires to have Consultant continue providing the services referenced in that Agreement; and

WHEREAS, the City and Consultant have agreed to extend the term of the Agreement an additional year, through December 31, 2020, and increase compensation for the extended term in the amount of Seventy-Five Thousand Dollars (\$75,000), annually.

NOW, THEREFORE, incorporating the recitals set out above, the parties hereto mutually agree to the following amendment to the Agreement.

- 1. Section 2, Term, is hereby amended to extend the term of the Agreement through December 31, 2020.
- 2. Section 3, Compensation, is hereby amended to increase for the extended term by Seventy-Five Thousand Dollars (\$75,000), annually, for a contract total of Five Hundred and Twenty-Five Thousand Dollars (\$525,000).
- 3. All other terms and conditions of the Agreement between the parties, which are not inconsistent with the terms of this First Amendment, shall remain in full force and effect as if fully set forth herein.
