## **DISCUSSION AND ACTION CALENDAR:**

1. Minutes of June 27, 2019:

Commissioner Mabon moved to approve,  $2^{nd}$  by Commissioner Kanatzar, abstention by Commissioner Bennett. Motion carried.

- 2. No action required on Commissioner D. McNulty's absence on June 27, 2019 due to resignation.
- Commissioner Bennett moved to consider Jacqueline McNulty's June 27, 2019 (no call) absence unexcused. 2<sup>nd</sup> by Commissioner Stancil. Commissioner Rooths abstained. Motion carried.



- 4. No action required on Commissioner Chitwood's June 27, 2019 absence due to resignation.
- 5. Commissioner Rooths moved to excuse Commissioner Bennett's (prior notice) absence. 2<sup>nd</sup> by Commissioner Stancil.

Motion carried unanimously.

6. Commissioner Bennett made a motion to approve 2019/2020 Budget. 2<sup>nd</sup> by Commissioner Rooths.

Motion carried unanimously.

- 7. Commissioner Rooths updated commissioners on the formation of a group of community and city staff members that are working on reaching out to Historically Black Colleges and Universities (HBCU) regarding the potential to bring a satellite campus to Riverside.
- 8. Commissioners affirmed that they would like to take part in the Municipality Equality Index in 2020 and directed staff to collect more information on the scoring system from other departments.
- 9. Commissioners Stancil, Rooths, Mabon, Imaku, and Ahmed volunteered to form an events subcommittee to determine the local events at which the Human Relations Commission should have a presence.

Commissioner Bennett moved to approve. 2<sup>nd</sup> by Stancil. Motion carried unanimously.
