

ORDINANCE NO.

AN ORDINANCE OF THE CITY OF RIVERSIDE, CALIFORNIA,
AMENDING SECTION 13.12.070 OF THE RIVERSIDE MUNICIPAL
CODE TO ADD AN ADDITIONAL SIX MONTH STREET OPENING
PERMIT OPTION

The City Council of the City of Riverside does ordain as follows:

Section 1: Section 13.12.070 is hereby amended as follows:

13.12.070 - Permit required.

It is unlawful for any person to tear up, excavate, open or remove any part of a street, alley, public parking space or public roadway easement in the City without first having obtained from the Public Works Director a written permit. Permits issued by the Public Works Director are not transferable under any circumstances and shall expire either six months or one year from the date of issuance at the discretion of the Public Works Director, after which time a new permit shall be required. At the discretion of the Public Works Director, a six month permit may be extended for an additional six months so that it expires 12 months after the date it was first issued.

Section 2: The City Council has reviewed the matter and, based upon the facts and information contained in the staff reports, administrative record, and written and oral testimony, hereby finds that this ordinance is not subject to CEQA pursuant to Sections 15060(c)(2), 15060(c)(3) and/or 15061(b)(3) of the State CEQA Guidelines, California Code of Regulations, Title 14, Chapter 3, in that it will not result in a direct or reasonably foreseeable indirect physical change in the environment nor have a significant impact on the environment.

Section 3: The City Clerk shall certify to the adoption of this ordinance and cause publication once, in a newspaper of general circulation in accordance with Section 414 of the Charter of the City of Riverside. This ordinance shall become effective on the 30th day after the date of its adoption.
