SUBJECT: GRANT FUNDS FROM RIVERSIDE COUNTY SHERIFF'S DEPARTMENT -

RIVERSIDE AUTO-THEFT INTERDICTION DETAIL TASK FORCE IN THE AMOUNT OF \$163,180.89 FOR FISCAL YEAR 2019-20 AND ADDENDUM TO MEMORANDUM OF UNDERSTANDING FOR THE MULTI-JURISDICTIONAL RIVERSIDE AUTO-THEFT INTERDICTION DETAIL - SUPPLEMENTAL

APPROPRIATION

ISSUES:

Approve the acceptance of grant funds from the Riverside County Sheriff's Department, Riverside Auto-Theft Interdiction Detail Task Force in the amount of \$163,180.89 for the period of July 1, 2019 through June 30, 2020; approve the Addendum to the Memorandum of Understanding for the multi-jurisdictional Riverside Auto-Theft Interdiction Detail; and authorize a supplemental appropriation in the amount of \$163,180.89.

RECOMMENDATIONS:

That the City Council:

- Approve the acceptance of grant funds from the Riverside County Sheriff's Department, Riverside Auto-Theft Interdiction Detail Task Force in the amount of \$163,180.89 for Fiscal Year 2019-20;
- 2. Approve the Addendum to the Memorandum of Understanding for the multi-jurisdictional Riverside Auto-Theft Interdiction Detail to reflect reimbursement terms for participating agencies and amending the signature block of the executive members;
- 3. Authorize, upon approval of grant acceptance, an increase in estimated revenues in the amount of \$163,180.89 in the Grants and Restricted Programs (Fund 215) RAID 19/20 Revenue Account and appropriate expenditures in the same amount to the Grants and Restricted Programs (Fund 215) Police Special Operations Expenditure Account; and
- 4. Authorize the City Manager, or designee, to execute the grant documents with the Riverside County Sheriff's Department, Riverside Auto-Theft Interdiction Detail Task Force, including making minor and non-substantive changes.

BACKGROUND:

In May of 1991, the Riverside County Board of Supervisors adopted a resolution pursuant to California Vehicle Code Section 9250.14, specifically to fund a multi-jurisdictional vehicle theft task force. The resolution was unanimously adopted, which resulted in an additional \$1.00 fee to be charged on each Riverside County new and renewed vehicle registration (\$2.00 for commercial vehicles). In February of 2009, Assembly Bill 286 was approved by the legislature and amends California Vehicle Code Section 9250.14 to ensure continued funding for the Riverside Auto-Theft Interdiction Detail.

The Riverside Auto-Theft Interdiction Detail (RAID) Task Force was formed in 1993. The multijurisdictional task force concentrates its efforts on the detection, identification, and apprehension of the professional vehicle thief operating in Riverside. The City Council approved the City's participation in RAID through a Memorandum of Understanding (MOU), on April 12, 1994 with a term expiring on January 1, 2020. The MOU outlines the organizational structure and formalizes the operating policies and procedures for RAID. The Riverside Police Department has one Police Detective assigned to the RAID Task Force, which is partially funded by AB 286.

DISCUSSION:

The mission of the Riverside Auto-Theft Interdiction Detail (RAID) Task Force is to reduce the incidence of vehicle theft and increase the apprehension of the professional vehicle thief. The task force is comprised of personnel from the California Highway Patrol, Riverside Sheriff's Department, Riverside Police Department, Murrieta Police Department, Indio Police Department, and Department of Insurance.

Vehicle theft remains a nationwide epidemic and is still one of the most costly property crimes in California. In 2018, the city of Riverside reported 1,845 auto thefts. The RAID Task Force combated vehicle crime through conducting 2,752 vehicle inspections, and recovered 544 vehicles with an estimated dollar value of \$5,885,100. In addition, auto theft investigations were conducted resulting in the arrest of 153 suspects, and 26 chop shop operations were identified and closed.

The RAID grant would fund one (1) full-time detective position, which includes 70 percent of the salary and benefits, and 150 hours of overtime, as well as equipment, training and other necessary operating expenses.

FISCAL IMPACT:

The total grant funds are \$163,180.89, with \$151,667.64 to reimburse 70 percent of salary and benefits for one Police Detective position and \$11,513.25 for 150 hours of annual overtime. The existing Police Department budget for Fiscal Year 2019-20 will absorb the remaining 30 percent (\$65,000.42) of salary and benefits for the Police Detective position.

Upon City Council authorization, an increase will be made to estimated revenues in the amount of \$163,180.89 to the Grants and Restricted Programs (Fund 215) RAID 19/20 Revenue Account No. 9340400-334100 and to appropriate expenditures in the same amount to the Gramts amd Restricted Programs (Fund 215) Police Special Operations Expenditure Account No. 9340400-440210.
