## RECITALS

- A. On December 16, 1987, the fee title owners of that certain real property more particularly described in Exhibit "A" attached hereto and made a part hereof ("Property"), were Helen M. Goldschmidt, Executor of the Will of Paul Goldschmidt, deceased, Lucile Goldschmidt, a widow and Adlai F. Goldschmidt, in trust (collectively "Owners"). The Property has since been subdivided and subsequently sold.
- B. As a condition of approval for Parcel Map 23026, the City required the then Owners of the Property to execute a document to be recorded which permitted the deferral of compliance of conditions of approval for right of way dedications, off-side improvements and plan preparations until such time as the Property was further subdivided or developed.
- C. In compliance with City requirements, a "Covenant and Agreement" dated December 16, 1987, was recorded on December 18, 1987 as Instrument No. 357272, Official Records of Riverside County, California ("Covenant").
- D. The City has determined that the obligations deferred in the Covenant have been met and the Covenant is no longer required.

### **TERMINATION**

- 1. <u>Termination</u>. The Covenant recorded on recorded on December 18, 1987, as Instrument No. 357272 is hereby terminated in its entirety and is of no further force and effect or burden on the Property.
- 2. <u>Consent of the City Council of the City of Riverside</u>. Pursuant to Paragraph 3 of the Covenant, the Covenant cannot be terminated or released without the consent of the City

Council of the City of Riverside, and by placement of the signature on this Termination, the City Council of the City of Riverside has expressly consented to the termination of the Covenant.
