

RESOLUTION NO.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, ORDERING, CALLING, PROVIDING FOR AND GIVING NOTICE OF A GENERAL MUNICIPAL ELECTION TO BE HELD IN THE CITY OF RIVERSIDE ON THE 3RD DAY OF MARCH, 2020, FOR THE PURPOSE OF ELECTING THE MAYOR OF SAID CITY OF RIVERSIDE, AND GIVING NOTICE AND ORDERING THAT SAID GENERAL MUNICIPAL ELECTION IS CONSOLIDATED WITH ALL OTHER ELECTIONS BEING HELD IN THE SAME TERRITORY ON THE SAME DATE.

The City Council of the City of Riverside does hereby resolve as follows:

Section 1: That in accordance with the provisions of Section 400 of the Charter of the City of Riverside and the Constitution and election laws of the State of California, a General Municipal Election be held and the same is hereby called and ordered to be held in the City of Riverside on March 3, 2020, for the purpose of electing the Mayor of the City of Riverside.

Section 2: That the polls for said election shall be opened at 7:00 a.m. of the day of said election and shall remain open continuously from said time until 8:00 p.m. of the same day, when the polls shall be closed, except as provided in Section 14401 of the Elections Code.

Section 3: That the City Council consents to the consolidation of the General Municipal Election hereby called with all other elections being held in the same territory on March 3, 2020, and said elections, where possible, shall be held in all respects as if there were only one election within the City of Riverside and only one form of ballot shall be used and the precincts, polling places and officers of election for said elections shall be the same as provided for the General Municipal Election.

Section 4: That for the purpose of holding said General Municipal Election there shall be and hereby are established consolidated voting precincts, consisting of a consolidation of the regular election precincts in the City of Riverside established for the holding of state and county elections as said regular election precincts exist on the date of this resolution.

Section 5: That the form and contents of the ballots to be used at the said elections shall be as provided by law.

1 Section 6: That in accordance with Section 10002 of the Elections Code, the Board of
2 Supervisors of Riverside County is hereby requested to consent to the Registrar of Voters
3 rendering election services to the City of Riverside as may be requested by the City Clerk of said
4 City, and that the County of Riverside is to be reimbursed in full for such services as are
5 performed.

6 Section 7: That the election services which the City of Riverside requests the Registrar
7 of Voters, or such other official as may be appropriate, to perform, and which such officer is
8 hereby authorized and directed to perform if the said Board of Supervisors consents, include: the
9 preparation, printing and mailing of sample ballots and polling place cards; the establishment or
10 appointment of precincts, polling places, and election officers, and making such publications as
11 are requested by law in connection therewith; the furnishing of ballots, voting booths and other
12 necessary supplies or materials for polling places; the canvassing of the returns of election and
13 the furnishing of the results of such canvassing to the City Clerk of the City of Riverside; and the
14 performance of such other election services as may be requested by said City Clerk.

15 Section 8: That the City Clerk shall have charge of all City elections pursuant to
16 Riverside City Charter Section 703(f).

17 Section 9: That the City Clerk is hereby designated the "Elections Official" for the
18 purposes of this election pursuant to Elections Code section 320(b).

19 Section 10: That based upon the foregoing authority, the City Clerk shall have charge of
20 this election and shall make all determinations necessary to conducting this election.

21 Section 11: That the City Clerk of said City shall receive the canvass of the General
22 Municipal Election and shall certify the results to this City Council, as required by law.
