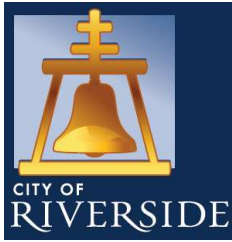
That the City Council:

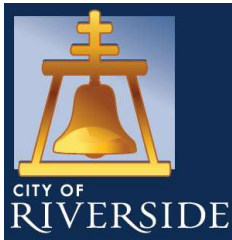

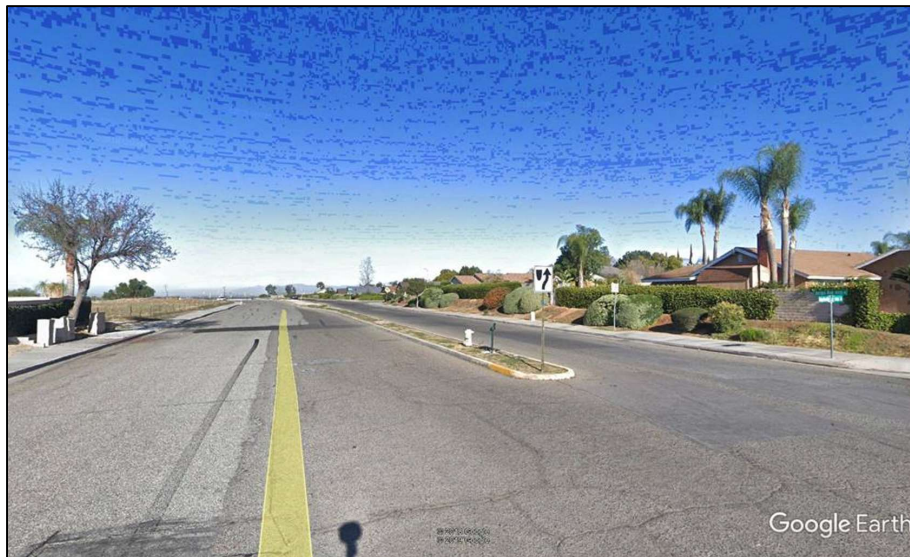
EXTENDED RUNWAY CENTERLINE VS. PROJECT SITE

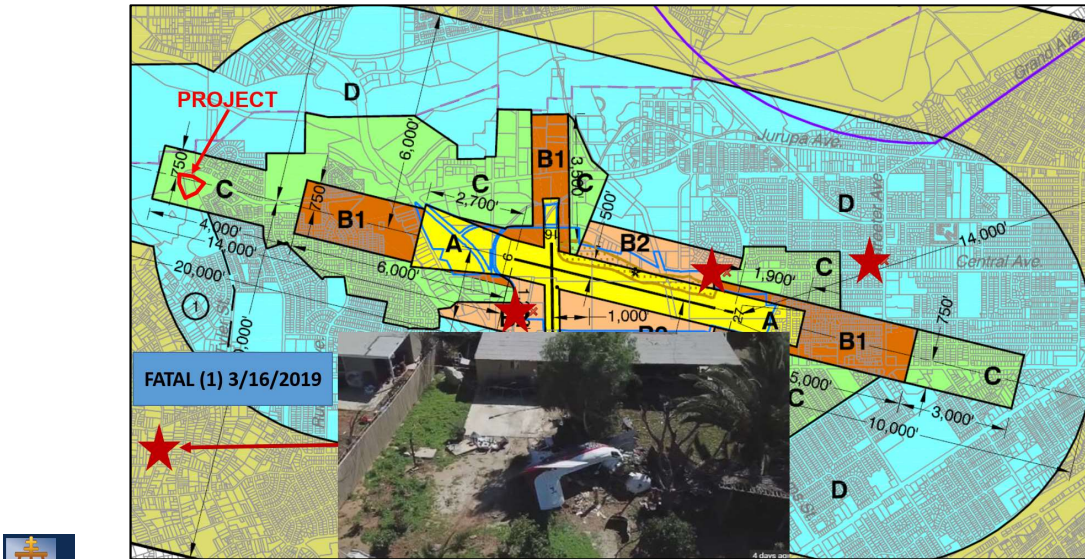
PROPOSED EMERGENCY LANDING "OPEN AREA"

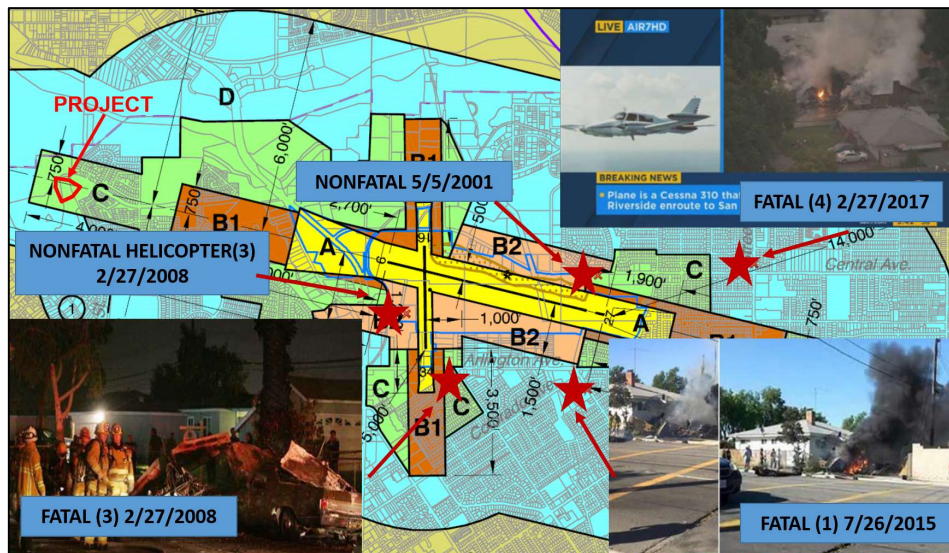
AIRCRAFT ACCIDENTS IN AIRPORT INFLUENCE AREA

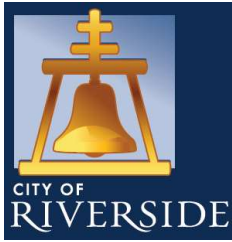
