Yes. In order to operate an ARCO AMPM we are required to allocate seven refrigerator doors for the sale of beer and wine. We are also required to comply with AMPM's plan-o-gram and promotions in sale of beer and wine. In fact, beer and wine are hallmark offerings of all convenience stores, without which they can not operate, rendering mute the intent

of the Zoning Code.

In addition we restrict the sale of beer and wine from 2 AM to 6 AM.
