

1 RESOLUTION NO.

2 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE,  
3 CALIFORNIA, AMENDING RESOLUTION NO. 22451 KNOWN AS THE  
4 MASTER PARKING SCHEDULE RESOLUTION TO ESTABLISH A  
5 PREFERENTIAL PARKING ZONE ON MT. RUBIDOUX.

6 WHEREAS, the Public Works Department received a petition from residents on Mt.  
7 Rubidoux Drive between University Avenue and the Buena Vista Bridge requesting the  
8 establishment of a No Parking Anytime Preferential Parking Zone ("PPZ") within the seven  
9 existing marked parking stalls on the east side of the street; and

10 WHEREAS, residents indicate that Mt. Rubidoux Park patron parking is limiting the  
11 availability of on-street parking opportunities near their homes for residents and guests and  
12 generating repeated vehicle break-ins and car alarm activations which result in noise, broken glass  
13 and debris; and

14 WHEREAS, on September 4, 2019, the Transportation Board unanimously recommended  
15 the establishment of the proposed PPZ on the east side of Mt. Rubidoux Drive within the seven  
16 marked parking stalls between University Avenue and the Buena Vista Bridge.

17 NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside,  
18 California, as follows:

19 Section 1: The recitals set forth above are incorporated herein by reference.

20 Section 2: That the Master Parking Schedule is hereby amended by establishing a "No  
21 Parking Any Time, with Preferential Permit Parking for residents" zone on the east side of Mt.  
22 Rubidoux Drive within the seven marked parking stalls between University Avenue and the  
23 Buena Vista Bridge.

24 Section 3: That the provisions of this resolution shall be operative only when signs are  
25 erected on that portion of the street set forth in Section 2 above, giving notice of the parking  
26 limitations or prohibitions herein established.

27 Section 4: The provisions of this amendment shall be operative as of the date of adoption  
28 of this resolution.
