

1 RESOLUTION NO.

2 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE,
3 CALIFORNIA, AMENDING RESOLUTION NO. 22451 KNOWN AS THE
4 MASTER PARKING SCHEDULE RESOLUTION TO ESTABLISH A TIMED
NO PARKING BUS LOADING ZONE ON LIMESTONE DRIVE.

5 WHEREAS, the Public Works Department received a request from the residents of 2919
6 Monroe Street to establish a timed No Parking Bus Loading Zone on the Limestone Drive side of
7 their property; and

8 WHEREAS, the zone is intended to provide unobstructed access to curbside loading for a
9 City special transportation bus that transports a disabled resident at the property daily Monday
10 through Friday with the exception of holidays to and from a special program; and

11 WHEREAS, existing conditions allow for vehicular parking within this area of Limestone
12 Drive which is frequently utilized by park patrons and/or nearby residents and often impedes bus
13 access to the property; and

14 WHEREAS, bus pick-up on the Monroe Street side of the property is not recommended
15 due to the higher volumes and speeds of traffic experienced on Monroe Street; and

16 WHEREAS, the restricted parking during scheduled bus pick-up and drop-of times would
17 provide immediate bus access to the property and facilitate the safe and efficient loading of the
18 disabled resident and enable their continued participation in the special program while allowing
19 for vehicular parking during non-restricted days and times; and

20 WHEREAS, on September 4, 2019, the Transportation Board unanimously recommended
21 the establishment of the proposed timed No Parking Bus Loading zone on the south side of
22 Limestone Drive from Monroe Street to 65 feet easterly thereof.

23 NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside,
24 California, as follows:

25 Section 1: The recitals set forth above are incorporated herein by reference.

26 Section 2: That the Master Parking Schedule is hereby amended by establishing a “No
27 Parking between the hours of 7:30 a.m. and 8:30 a.m. to 1:30 p.m. and 3:30 p.m. Monday through

1 Friday except Holidays, Bus Loading Zone” on the south side of Limestone Drive from Monroe
2 Street to 65 feet easterly thereof.

3 Section 3: That the provisions of this resolution shall be operative only when signs are
4 erected on that portion of the street set forth in Section 2 above, giving notice of the parking
5 limitations or prohibitions herein established.

6 Section 4: The provisions of this amendment shall be operative as of the date of adoption
7 of this resolution.
