1 RESOLUTION NO. 2 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, AMENDING RESOLUTION NO. 22451 KNOWN AS THE 3 MASTER PARKING SCHEDULE RESOLUTION TO ESTABLISH A TIMED NO PARKING BUS LOADING ZONE ON LIMESTONE DRIVE. 4 WHEREAS, the Public Works Department received a request from the residents of 2919 5 Monroe Street to establish a timed No Parking Bus Loading Zone on the Limestone Drive side of 6 their property; and WHEREAS, the zone is intended to provide unobstructed access to curbside loading for a 8 City special transportation bus that transports a disabled resident at the property daily Monday 9 through Friday with the exception of holidays to and from a special program; and 10 WHEREAS, existing conditions allow for vehicular parking within this area of Limestone 11 Drive which is frequently utilized by park patrons and/or nearby residents and often impedes bus 12 access to the property; and 13 WHEREAS, bus pick-up on the Monroe Street side of the property is not recommended 14 due to the higher volumes and speeds of traffic experienced on Monroe Street; and 15 WHEREAS, the restricted parking during scheduled bus pick-up and drop-of times would 16 provide immediate bus access to the property and facilitate the safe and efficient loading of the 17 disabled resident and enable their continued participation in the special program while allowing 18 for vehicular parking during non-restricted days and times; and 19 WHEREAS, on September 4, 2019, the Transportation Board unanimously recommended 20 the establishment of the proposed timed No Parking Bus Loading zone on the south side of 2.1 Limestone Drive from Monroe Street to 65 feet easterly thereof. 22 23 NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside, 2.4 California, as follows: <u>Section 1</u>: The recitals set forth above are incorporated herein by reference. 25 Section 2: That the Master Parking Schedule is hereby amended by establishing a "No 26 27 Parking between the hours of 7:30 a.m. and 8:30 a.m. to 1:30 p.m. and 3:30 p.m. Monday through 28

1	Friday except Holidays, Bus Loading Zone" on the south side of Limestone Drive from Monroe
2	Street to 65 feet easterly thereof.
3	Section 3: That the provisions of this resolution shall be operative only when signs are
4	erected on that portion of the street set forth in Section 2 above, giving notice of the parking
5	limitations or prohibitions herein established.
6	Section 4: The provisions of this amendment shall be operative as of the date of adoption
7	of this resolution.
