ORDINANCE NO. 1 AN ORDINANCE OF THE CITY OF RIVERSIDE, CALIFORNIA, AMENDING CHAPTER 2.12 OF THE RIVERSIDE MUNICIPAL CODE AS 2 TO THE NAME OF THE MUSEUM, AND THE DUTIES OF THE BOARD. 3 AND THE NUMBER OF MEMBERS ON THE BOARD. 4 5 The City Council of the City of Riverside does ordain as follows: 6 Section 1: The Table of Contents of Chapter 2.12 of the Riverside Municipal Code entitled 7 "Museum" is amended in part as follows: 8 9 "Chapter 2.12 – MUSEUM 10 **Sections:** 11 2.12.005 – Name of museum and branches 12 2.12.010 - Metropolitan Museum of Riverside Board established 2.12.020 - Duties of Metropolitan Museumuseum of Riverside Board 13 2.12.030 – Administrative objectives 2.12.040 – Title to property 14 2.12.050 - Special fund created" 15 16 Section 2: Section 2.12.005 of the Riverside Municipal Code entitled "Name of museum and 17 branches" is hereby amended as follows: 18 "2.12.005 - Name of museum and branches. 19 The collective name for all museum facilities shall be the "Riverside Metropolitan Museum Museum 20 of Riverside." Individual facilities may be individually named but formally referred to as part of the Riverside Metropolitan Museum Museum of Riverside." 21 22 Section 3: Section 2.12.010 of the Riverside Municipal Code entitled "Metropolitan Museum 23 of Riverside Board established" is hereby amended as follows: 24 "2.12.010 - Metropolitan Museum Museum of Riverside Board established. 25 26 There is hereby created, pursuant to Section 800 of the City Charter, a Museum Board for the Metropolitan Museum Museum of Riverside, which shall consist of nine members appointed by the 27 Mayor and City Council. The Museum Director or his/her representative shall attend all meetings of this board and be responsible for maintaining all records and minutes." 28 Section 4: Section 2.12.020 of the Riverside Municipal Code entitled "Duties of Metropolitan Museum of Riverside Board" is hereby amended as follows:

K.J. Initiate any other recommendations to the City Council and City Manager concerning the development, care, maintenance, operation and welfare of the Museum, and make recommendations on such other museum matters as the City Council or City Manager may request;

L.K. Perform such other advisory functions relating to museum activities as may be desired by the City Council."

<u>Section 5</u>: Section 2.12.040 of the Riverside Municipal Code entitled "Title to Property" is hereby amended as follows:

"2.12.040 - Title to property.

The title to all real and personal property acquired and utilized by the Riverside Metropolitan Museum Museum of Riverside or any of its branches, when not otherwise designated by terms of its acquisition, shall vest in the City."

Section 6: Section 2.12.050 of the Riverside Municipal Code entitled "Special fund created" is hereby amended as follows:

"2.12.050 - Special fund created.

There is hereby created a special fund of the City, to be known as the "Museum Fund." Revenues derived from any allowable special fees, from the sale of inappropriate artifacts, or from any real property held in the name of the Metropolitan Museum Museum of Riverside Board, together with all moneys acquired through gift, bequest or otherwise which have been specifically designated for museum purposes, shall be deposited in the City Treasury to the credit of such fund. They shall be kept separate and apart from all other moneys of the City, and shall be devoted exclusively to museum purposes."

Section 7: The City Council has reviewed the matter and, based upon the facts and information contained in the staff reports, administrative record, and written and oral testimony, hereby finds that this ordinance is not subject to CEQA pursuant to Sections 15060(c)(2), 15060(c)(3) and/or 15061(b)(3) of the State CEQA Guidelines, California Code of Regulations, Title 14, Chapter 3, in that it will not result in a direct or reasonably foreseeable indirect physical change in the environment nor have a significant impact on the environment.

1	Section 8: The City Clerk shall certify to the adoption of this ordinance and cause publication

3	once in a newspaper of general circulation in accordance with Section 414 of the Charter of the City
4	of Riverside. This ordinance shall become effective on the 30th day after the date of its adoption.
