AIRPORT MANAGER REPORT

Recent City Council Actions:

- October 8, 2019, City Council approved a License Agreement with StratosShare, Inc. to allow the pre-positioning of up to ten, hydrogen powered vehicles in the Airport parking lot for public rental.
- October 8, 2019, the City Council approved an Access Agreement between CBU Aviation Department in accordance with FAA requirements for off-airport entities to access the airfield of Riverside Municipal Airport.
- On October 8, 2019, the City Council approved a \$261,000 appropriation from the Airport Enterprise Fund to meet emergency needs, and unfunded facility and maintenance projects. Projects include demolition of a structure located at 6711 Doolittle Avenue, HVAC replacement and repairs for airport buildings, and asphalt repairs.

Recent City Council Actions:

- On October 22, 2019, the City Council approved a Non-Exclusive License Agreement with Blackstone Airways, LLC. This airline is introducing on-demand charter flights from Riverside Municipal Airport to multiple destinations in California.
- On October 22, 2019, the City Council approved a long-term Lease Agreement with ATP CA, Inc., doing business as ATP Training, operating as a Limited Fixed-Base Operator providing flight-training services. The long-term lease agreement is in alignment with the 2012 Riverside Municipal Airport goal of converting commercial month-to-month lease agreements to long-term agreements to promote commercial investment.

- October 9, 2019, Airport issued Request for Qualifications (RFQ) No.1981, seeking an on-call airport design consultant to provide support in construction design and management, and applications for federal and state grant applications.
- Airport staff is finalizing a Request for Proposals (RFP) to seek an entity to conduct a semi-annual Airshow, beginning in 2021.
