1 RESOLUTION NO. 2 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, AMENDING RESOLUTION NO. 22451 KNOWN AS THE 3 MASTER PARKING SCHEDULE RESOLUTION TO ESTABLISH A PREFERENTIAL PARKING ZONE ON RAILROAD AVENUE. 4 WHEREAS, the Public Works Department received a petition from a resident at 7891 5 Railroad Avenue requesting the establishment of a timed no parking Preferential Parking Zone 6 ("PPZ") at the frontage of the property; and 7 WHEREAS, this property is one of two properties located on the east of Railroad Avenue 8 and the only residence which fronts this portion of the street; and 9 WHEREAS, the resident indicates that overflow parking from nearby auto dealerships and 10 area businesses is impacting availability of on-street parking for himself, other residents at the 11 property, and their guests during peak business hours; and 12 WHEREAS, the establishment of the proposed PPZ would restrict outside parking sources 13 and provide the residents and guests of 7891 Railroad Avenue reasonable access to on-street 14 parking near their residence during peak business hours; 15 WHEREAS, on September 4, 2019, the Transportation Board recommended an amended 16 version of the proposed PPZ on the east side of Railroad Avenue from Casa Blanca Street to 95 17 feet southerly thereof rather than the originally proposed boundaries of Case Blanca Street to 165 18 feet southerly thereof. 19 NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside, 20 California, as follows: 2.1 Section 1: The recitals set forth above are incorporated herein by reference. 22 Section 2: That the Master Parking Schedule is hereby amended by establishing a "No 23 2.4 Parking between the hours of 8:00 a.m. to 6:00 a.m. Monday through Saturday, with Preferential 25 Permit Parking for residents" zone on the east side of Railroad Avenue from Casa Blanca Street to 95 feet southerly thereof. 26 27

2	erected on that portion of the street set forth in Section 2 above, giving notice of the parking
3	limitations or prohibitions herein established.
4	Section 4: The provisions of this amendment shall be operative as of the date of adoption
