## 1 ORDINANCE NO. AN ORDINANCE OF THE CITY OF RIVERSIDE, CALIFORNIA, AMENDING 2 THE ZONING MAP OF THE CITY OF RIVERSIDE PURSUANT TO CHAPTER 3 19.090 OF THE RIVERSIDE MUNICIPAL CODE BY REZONING PROPERTY LOCATED ON THE NORTHEAST CORNER OF CALIFORNIA AVENUE AND 4 HOLE AVENEUE, FROM THE R-1-7000 - SINGLE FAMILY RESIDENTIAL ZONE TO CR – COMMERICAL RETAIL ZONE. 5 6 The City Council of the City of Riverside, California, does ordain as follows: 7 Section 1: Pursuant to Chapter 19.090 of the Riverside Municipal Code, the Zoning Map of 8 the City of Riverside is amended by removing from the R-1-7000 Single Family Residential Zone 9 and placing in the CR – Commercial Retail Zone, the property located on the Northwest corner of 10 California Avenue and Hole Avenue, as described and depicted in Exhibits "A" and "B" attached 11 hereto and incorporated herein by reference, subject to all of the conditions, restrictions and 12 covenants imposed under Planning Case Number P17-0691, which conditions, restrictions and 13 covenants are incorporated herein by reference. 14 Section 2: The City Clerk shall certify to the adoption of this Ordinance and cause 15 publication once in a newspaper of general circulation in accordance with Section 414 of the Charter 16 of the City of Riverside.
