SUBJECT: RESOLUTION ACKNOWLEDGING RECEIPT OF THE 2019 REPORT

REGARDING ANNUAL INSPECTION OF CERTAIN OCCUPANCIES REQUIRED PURSUANT TO SECTIONS 13146.2 AND 13146.3 OF THE CALIFORNIA

HEALTH AND SAFETY CODE

ISSUE:

Adopt a Resolution acknowledging receipt of the 2019 report regarding the annual inspection of certain occupancies required pursuant to Sections 13146.2 and 13146.3 of the California Health and Safety Code.

RECOMMENDATION:

That the City Council adopt a Resolution acknowledging receipt of the 2019 report regarding the annual inspection of certain occupancies required pursuant to Sections 13146.2 and 13146.3 of the California Health and Safety Code.

BACKGROUND:

Existing laws in the State of California require Fire Departments to enforce California Health and Safety Code Sections 13145, 13146 and 17921 as adopted. Additionally, Fire Departments are required to perform annual inspections on every building used as a public or private school, apartment houses, hotels, motels, lodging houses and jails for compliance with adopted fire codes.

DISCUSSION:

In accordance to State Legislature, the Fire Department was assigned 1,635 mandated inspections, with 1,360 of those completed and 275 not completed.
