## RESOLUTION NO.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, RECITING THE FACT OF THE SPECIAL MUNICIPAL RUNOFF ELECTION HELD IN SAID CITY ON THE 5TH DAY OF NOVEMBER, 2019 DECLARING THE RESULTS THEREOF AND SETTING FORTH SUCH OTHER MATTERS AS ARE PROVIDED BY LAW.

WHEREAS, a Special Municipal Runoff Election was held and conducted in the City of Riverside on the 5th day of November, 2019, as required by law for the purpose of electing members of the City Council for Wards 1, 3, 5 and 7; and

WHEREAS, notice of said election was duly and regularly given in the time, form and manner as provided by law; voting precincts were properly established; election officers were appointed and in all respects said election was held and the returns made and declared in the time, form, and manner as required by the provisions of the Charter of the City of Riverside and the Elections Code of the State of California for the holding of elections in the City of Riverside; and

WHEREAS, pursuant to Resolution No. 23465 adopted on the 2nd day of July, 2019, the appropriate County official canvassed the returns of said election and has certified the results to this City Council and said results are received, attached, and made a part hereof as Exhibit "A".

NOW THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside, as follows:

Section 1: That there were eleven (11) voting precincts in the First Ward; eleven (11) voting precincts in the Third Ward; ten (10) voting precincts in the Fifth Ward; seven (7) voting precincts in the Seventh Ward; and thirty-nine (39) voting precincts citywide.

<u>Section 2:</u> That said Special Municipal Runoff Election was held for the purpose of electing four (4) members of the City Council of the City of Riverside from Wards 1, 3, 5 and 7 of the City of Riverside as established by the City Council for five-year terms.

<u>Section 3</u>: That the whole number of votes cast in the First Ward in the City of Riverside was \_\_\_\_; that the whole number of votes cast in the Third Ward in the City of Riverside was \_\_\_\_; that the whole number of votes cast in the Fifth Ward in the City of Riverside was \_\_\_\_; and that

the whole number of votes cast in the Seventh Ward in the City was \_\_\_\_. 1 2 <u>Section 4:</u> That the names of the persons voted for at said election and the office which each person was voted for are as follows: 3 CITY COUNCIL, WARD 1: 4 **ERIN EDWARDS** for Member of the City Council 5 MIKE GARDNER for Member of the City Council 6 CITY COUNCIL, WARD 3: 7 WARREN AVERY for Member of the City Council 8 for Member of the City Council RONALDO FIERRO 9 **CITY COUNCIL, WARD 5:** 10 for Member of the City Council **GABY PLASCENCIA** 11 **SEAN MILL** for Member of the City Council 12 **CITY COUNCIL, WARD 7:** 13 WILLIAM D. PEARCE for Member of the City Council 14 STEVE HEMENWAY for Member of the City Council 15 That the number of votes given at each precinct and the number of votes given in the City 16 to each of said persons above named for the respective offices for which said persons were 17 candidates are listed on the attached Exhibit "A". 18 Section 5: That the City Council does declare and determine that Erin Edwards was 19 elected as a member of the City Council from the First Ward of said City to serve for the full 20 term of five years. 21 Section 6: That the City Council does declare and determine that Ronaldo Fierro was 22 elected as a member of the City Council from the Third Ward of said City to serve for the full 23 term of five years. 24 Section 7: That the City Council does declare and determine that Gaby Plascencia was 25 elected as a member of the City Council from the Fifth Ward of said City to serve for the full 26 term of five years.

Section 8: That the City Council does declare and determine that Steve Hemenway 1 2 was elected as a member of the City Council from the Seventh Ward of said City to serve for the full term of five years. 3 Section 9: That the City Clerk shall enter on the records of the City Council of said City 4 a statement of the results of the Special Municipal Runoff Election held on November 5, 2019, 5 showing: 6 The whole number of votes cast in the City; (1) 7 (2) The names of the persons voted for; 8 (3) The office each person was voted for; 9 The number of votes given at each precinct to each of said persons; and (4) 10 (5) The number of votes given in the City to each of said persons; 11 Section 10: That pursuant to Section 400 of the Riverside City Charter and Election 12 Code §10265, the City Clerk shall deliver to the person so elected, a Certificate of Election 13 signed by her and duly authenticated; that she shall also administer to each person elected, the 14 Oath of Office prescribed in the State Constitution of the State of California and shall have them 15 subscribe thereto and file the same in her office; whereupon, said persons so elected shall be 16 inducted in to the office to which they have been elected. 17 ADOPTED by the City Council this \_\_\_\_ day of December, 2019. 18 19 20 21 WILLIAM R.
