ORDINANCE NO. 1 AN ORDINANCE OF THE CITY OF RIVERSIDE, CALIFORNIA, AMENDING 2 THE ZONING MAP OF THE CITY OF RIVERSIDE PURSUANT TO CHAPTER 3 19.090 OF THE RIVERSIDE MUNICIPAL CODE BY REZONING PROPERTY LOCATED AT 3444 CENTER STREET, BETWEEN ORANGE AND CLAIRE 4 STREETS, FROM THE R-1-7000 - SINGLE FAMILY RESIDENTIAL ZONE TO R-1-7000-MH – SINGLE FAMILY RESIDENTIAL AND MOBILE HOME PARK 5 OVERLAY ZONES. 6 The City Council of the City of Riverside, California, does ordain as follows: 7 Section 1: Pursuant to Chapter 19.090 of the Riverside Municipal Code, the Zoning Map of 8 the City of Riverside is amended by removing from the R-1-7000 Single Family Residential Zone 9 and placing in the R-1-7000-MH – Single Family Residential and Mobile Home Park Overlay 10 Zones, the property located at 3444 Center Street, between Orange and Claire Streets, as described 11 and depicted in Exhibit "A" attached hereto and incorporated herein by reference, subject to all of 12 the conditions, restrictions and covenants imposed under Planning Case Number P18-0020, which 13 conditions, restrictions and covenants are incorporated herein by reference. 14 Section 2: The City Clerk shall certify to the adoption of this Ordinance and cause 15 publication once in a newspaper of general circulation in accordance with Section 414 of the Charter 16 of the City of Riverside.
