Dear Planning Commissioners,

I am asking that you **not approve** the project located at **3740 Park Sierra Drive**. This project needs several variances to be approved. Code has been established to protect communities, variances are a "way around" the city code and in this case to the detriment of our community. This project is **NOT APPROPRIATE at this location**. Years ago, In Cahoots was located next to El Torito at 3742 Park Sierra Dr, Riverside, CA 92505-3062. There were complaints to the police every weekend and to our City Councilman, Jim Perry. The proposed business is described as a dance studio by day and on weekends as a banquet facility which will **host ENTERTAINMENT**. This is a BROAD use and the translation is terrifying to neighbors. Entertainment equals crowds, loud music, pulsating bass and disruption to the hospital within 600 feet of this likely cacophonous venue. This noise travels via vibrations throughout the neighborhoods and is a disruption to the quality of life to neighbors wanting quiet in the **residential** neighborhood.

2 Variances are being requested:

LIQUOR LICENSE: This project is asking for a variance to have a **liquor license approved**. If they need a variance for a liquor license that suggests this property is NOT ELIGIBLE for a liquor license. The Red Lobster is located at 3700 :Park Sierra and has a liquor license that was most likely grandfathered in. Kaiser Permanente Hospital is at this location with a Magnolia address but borders both Park Sierra and Polk Street. A **weekend "entertainment" hall** should not be approved to be built next to a hospital; they share the same parking lot. Nor should it be in close proximity to residences.

LACK OF PARKING. The developer is asking for a **variance for parking**. The proposed facility is expected to be ~ 10,000+ square feet with a requirement (I have been told) of 150 parking places. I believe this facility has ~50 parking places but anticipates sharing the parking with the Red Lobster and the hospital without the sanction of either.

Riverside needs to stop granting variances based on relationships of the developer/the property owner and city staff/employees but on the merit of the request.

The following is a definition I read for granting variances.:

the variance request is justified only if special conditions exist on the lot that create a hardship making it too difficult to comply with the code's normal requirements. Likewise, a request for a variance on a normal lot with no special conditions could judiciously be denied. The special conditions or hardship typically must arise from some physical configuration of the lot or its structures. The financial or personal situation of the applicant normally cannot be taken into consideration. Under most codes governing variances, approval of the variance must not result in a public health or safety hazard and must not grant special privilege to the property owner. In other words, when a variance is granted, any other property owner with similar site conditions should be able to obtain a similar variance; this criterion is often addressed by citing precedent.

I am asking that you **not approve** the project located at **3740 Park Sierra Drive**. It is NOT appropriate for this area. I am asking that the variances requested not be granted..
