

1 RESOLUTION NO.

2 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE,  
3 CALIFORNIA, AMENDING RESOLUTION NO. 22451 KNOWN AS THE  
4 MASTER PARKING SCHEDULE RESOLUTION TO ESTABLISH A TIMED  
NO STOPPING ZONE ON AMBER STREET.

5 WHEREAS, the Public Works Department received a petition from both of the two  
6 directly impacted residents (equivalent to 100%) with properties immediately adjacent to the  
7 affected area of Amber Street requesting establishment of a timed No Stopping zone on both sides  
8 of the street from the southerly terminus south of Haskell Street to 40 feet northerly thereof; and

9 WHEREAS, residents indicate that this area at the end of Amber Street, which sits  
10 adjacent to a small undeveloped parcel owned by the City's Public Utilities Department, attracts  
11 motorists stopping in their vehicles and engaging in partying and/or illegal and illicit activity  
12 during nighttime and early morning hours; and

13 WHEREAS, the establishment of the proposed timed No Stopping zone would restrict late  
14 night and early morning stopping within the designated segments of Amber Street and aid in  
15 reducing or eliminating illegal and illicit activity, noise generated by parked motorists, littering,  
16 and resident safety concerns while retaining sufficient adjacent on-street parking for residents  
17 closer to Haskell Street; and

18 WHEREAS, the restriction would reduce similar activity from occurring at the entrance to  
19 the Public Utilities owned parcel; and

20 WHEREAS, on November 6, 2019, the Transportation Board unanimously recommended  
21 the establishment of the proposed timed No Stopping zone on the designated segment of Amber  
22 Street.

23 NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside,  
24 California, as follows:

25 Section 1: The recitals set forth above are incorporated herein by reference.

26 Section 2: That the Master Parking Schedule is hereby amended by establishing a "No  
27 Stopping Between the Hours of 6:00 p.m. to 6:00 a.m. Daily" zone on both sides of Amber Street  
28 from the southerly terminus south of Haskell Street to 40 feet northerly thereof.

Section 3: That the provisions of this resolution shall be operative only when signs are erected on that portion of the street set forth in Section 2 above, giving notice of the parking limitations or prohibitions herein established.

Section 4: The provisions of this amendment shall be operative as of the date of adoption of this resolution.
