1 RESOLUTION NO. 2 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE. CALIFORNIA, AMENDING RESOLUTION NO. 22451 KNOWN AS THE 3 MASTER PARKING SCHEDULE RESOLUTION TO ESTABLISH A TIMED NO STOPPING ZONE ON MINNIER AVENUE. 4 WHEREAS, the Public Works Department received a request to establish a timed No 5 Stopping zone on the west side of Minnier Avenue from Whitford Avenue to 350 feet southerly 6 thereof to address concerns related to motorists stopping in this predominantly unimproved area to loiter, engage in partying and/or illegal activity during nighttime and early morning hours; and 8 WHEREAS, the establishment of the proposed timed No Stopping zone would restrict late 9 night and early morning stopping within the designated segment of Minnier Avenue; and 10 WHEREAS, the restriction would serve to reduce or eliminate loitering, illegal and illicit 11 activity, noise, littering, and area resident safety concerns; and 12 WHEREAS, on November 6, 2019, the Transportation Board unanimously recommended 13 the establishment of the proposed timed No Stopping zone on the designated segment of the west 14 side of Minnier Avenue. 15 NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside, 16 California, as follows: 17 <u>Section 1</u>: The recitals set forth above are incorporated herein by reference. 18 <u>Section 2</u>: That the Master Parking Schedule is hereby amended by establishing a "No 19 Stopping Between the Hours of 10:00 p.m. to 6:00 a.m. Daily" zone on the west side of Minnier 20 Avenue from Whitford Avenue to 350 feet southerly thereof. 21 Section 3: That the provisions of this resolution shall be operative only when signs are 22 23 erected on that portion of the street set forth in Section 2 above, giving notice of the parking 2.4 limitations or prohibitions herein established. 25 <u>Section 4</u>: The provisions of this amendment shall be operative as of the date of adoption of this resolution. 26 27 28
