

RESOLUTION NO.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, PAYING AND REPORTING THE VALUE OF EMPLOYER PAID MEMBER CONTRIBUTIONS, EFFECTIVE JANUARY 10, 2020.

WHEREAS, the City Council of the City of Riverside has the authority to implement Government Code Section 20636(c)(4) pursuant to Section 20691; and

WHEREAS, the City Council of the City of Riverside has a written labor agreement which specifically provides for the normal member contributions to be paid for by the employer, and reported as additional compensation; and

WHEREAS, one of the steps in the procedures to implement Section 20691 is the adoption by the City Council of the City of Riverside of a Resolution to commence paying and reporting the value of said Employer Paid Member Contributions (EPMC); pursuant to CCR title 2 section 571(a)(1); and

WHEREAS, the City Council of the City of Riverside has identified the following conditions for the purpose of its election to pay EPMC:

- This benefit shall apply to all employees of the unrepresented units hired on or before October 18, 2011: Executive (Non-Safety), Senior Management, Management, Professional, Para-Professional, Supervisory and Confidential. This benefit shall consist of the Employer paying 2% of the normal member contribution as EPMC, and reporting the same percent (2%) as compensation earnable (excluding Government Code Section 20636(c)(4) as additional compensation.
- This benefit shall apply to all Tier 1 employees of the Riverside Police Officers' Association Unit hired between February 17, 2012 and June 12, 2012. This benefit shall consist of paying 4.5% of the normal member contribution as EPMC, and reporting the same percent (4.5%) as compensation earnable (excluding Government Code Section 20636(c) as additional compensation.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside, California, as follows:

Section 1: That the above recitals are found to be true and correct and are hereby incorporated as if stated in full.

1	Section 2: That the City Council elects to pay and report the value of Employer Paid				
2	Member Contributions for all employees of the unrepresented units hired on or before October				
3	18, 2011: Executive (Non-Safety), Senior Management, Management, Professional, Para-				
4	Professional, Supervisory and Confidential. This benefit shall consist of the Employer paying 2%				
5	of the normal member contribution as EPMC, and reporting the same percent (2%) as				
6	compensation earnable (excluding Government Code Section 20636(c)(4) as additional				
7	compensation.				
8	Section 3: That the City Council elects to pay and report the value of Employer Paid				
9	Member Contributions for all Tier 1 employees of the Riverside Police Officers' Association				
10	Unit hired between February 17, 2012 and June 12, 2012. This benefit shall consist of paying				
11	4.5% of the normal member contribution as EPMC, and reporting the same percent (4.5%) as				
12	compensation earnable (excluding Government Code Section 20636(c) as additional				
13	compensation.				
14	Section 4: That this resolution shall become effective on January 10, 2020.
