

1 RESOLUTION NO.

2 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE,  
3 CALIFORNIA, AMENDING RESOLUTION NO. 22451 KNOWN AS THE  
4 MASTER PARKING SCHEDULE RESOLUTION TO REMOVE A SEGMENT  
5 OF TIMED 2-HOUR PARKING ZONE AND TO CORRECT THE  
6 REMAINING NORTHERLY ZONE BOUNDARY ON PARK AVENUE.

7 WHEREAS, the Public Works Department received a petition from 86% of businesses  
8 and residents located on both sides of Park Avenue between Eleventh and Twelfth Streets  
9 requesting removal of the existing 2-Hour Parking zone within this segment of Park Avenue; and

10 WHEREAS, businesses within this area indicate that several of their patrons have received  
11 parking citations for exceeding the time limit and that services provided often extend beyond the  
12 2-Hour maximum; and

13 WHEREAS, as a result, businesses state that the 2-Hour Parking zone no longer meets  
14 their needs and those of their clients and they request removal of the zone to enable longer  
15 duration parking; and

16 WHEREAS, removal of the proposed segment of existing 2-Hour Parking zone would  
17 better meet the current needs of area businesses and residents by providing convenient, longer-  
18 term parking for business patrons, area residents, and their guests; and

19 WHEREAS, the existing 2-Hour Parking zones on both sides of Park Avenue from  
20 Mission Inn Avenue (formerly Seventh Street) to Eleventh Street and from Twelfth Street to  
21 Fourteenth Street will remain in effect; and

22 WHEREAS, the remaining northerly 2-Hour Parking zone requires a correction to the  
23 zone boundaries changing the northerly boundary from its former name of "Seventh Street" to the  
24 current street name of "Mission Inn Avenue"; and

25 WHEREAS, on November 6, 2019, the Transportation Board unanimously recommended  
26 the removal of the segment of existing timed 2-Hour Parking zone on both sides of Park Avenue  
27 from Eleventh Street to Twelfth Street and correction of the northerly zone boundary of the  
28 remaining 2-Hour Parking zone.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside,  
California, as follows:

1           Section 1: The recitals set forth above are incorporated herein by reference.

2           Section 2: That the Master Parking Schedule is hereby amended by 1) removing the  
3 segment of the existing “2-Hour Parking 9:00 a.m. to 6:00 p.m. except Sunday and holidays” zone  
4 on both sides of Park Avenue from Eleventh Street to Twelfth Street; and 2) correcting the  
5 boundaries of the remaining northerly “2-Hour Parking 9:00 a.m. to 6:00 p.m. except Sunday and  
6 holidays” zone changing the northerly boundary from its former name of “Seventh Street” to the  
7 current street name of “Mission Inn Avenue”.

8           Section 3: That the provisions of this resolution shall be operative only when signs are  
9 erected on that portion of the street set forth in Section 2 above, giving notice of the parking  
10 limitations or prohibitions herein established.

11           Section 4: The provisions of this amendment shall be operative as of the date of adoption  
12 of this resolution.
