SUBJECT: BOARD AND COMMISSION APPOINTMENTS, REDESIGNATION, AND RESIGNATIONS

ISSUES:

Appoint Luz Negrón to the Ward 2 seat on the Museum of Riverside Board, Gary Montgomery to the Citywide Business seat on the Budget Engagement Commission, and Aram Ayra to the Citywide seat on the Human Relations Commission; redesignate Jose R. Arballo from the Ward 2 Resident seat to the Citywide Resident seat on the Budget Engagement Commission; and accept the resignations of Rose M. Mayes, Ronaldo Fierro, and Gaby Plascencia from the Budget Engagement Commission, Citywide Business, Ward 1 Business, and Citywide Resident seats, respectively; Jennifer O'Farrell from the Board of Public Utilities Ward 1 seat; Karen J. Brown from the Human Resources Board Ward 6 seat; and Dawn C. McNulty from the Human Relations Commission Ward 7 seat.

RECOMMENDATIONS:

That the Mayor and City Council:

1. Appoint (a) Luz Negrón to the Ward 2 seat on the Museum of Riverside Board for a term ending March 1, 2023; (b) Gary Montgomery to the Citywide Business seat on the Budget Engagement Commission for a term ending March 1, 2021; and (c) Aram Ayra to the Citywide seat on the Human Relations Commission for a term ending March 1, 2024;
2. Redesignate Jose R. Arballo from the Ward 2 Resident seat to the Citywide Resident seat on the Budget Engagement Commission for a term ending March 1, 2021;
3. Accept the resignations of (a) Rose M. Mayes, Ronaldo Fierro, and Gaby Plascencia from the Budget Engagement Commission Citywide Business, Ward 1 Business, and Citywide Resident seats, respectively; (b) Jennifer O'Farrell from the Board of Public Utilities Ward 1 seat; (c) Karen J. Brown from the Human Resources Board Ward 6 seat; and (d) Dawn C. McNulty from the Human Relations Commission Ward 7 seat, effective immediately; and
4. Request the City Clerk to process the vacancies.

BACKGROUND/LEGISLATIVE HISTORY:

Councilmember Melendrez recommends appointment of Luz Negrón to the Ward 2 seat on the Museum of Riverside Board for a term ending March 1, 2023. Pursuant to Charter Section 802,

each board and commission must have at least one representative from each of the Council Wards. This appointment complies with the Charter requirement.

On November 18, 2019, the City Clerk's Office received a resignation from Jennifer O'Farrell from the Board of Public Utilities Ward 1 seat, effective December 31, 2019. Ms. O'Farrell's term on the Board expires on March 1, 2023.

On November 21, 2019, the City Clerk's Office received a resignation from Karen J. Brown from the Human Resources Board Ward 6 seat, effective immediately. Ms. Brown's term on the Board expires on March 1, 2021.

On December 3, 2019, the City Clerk's Office received a resignation from Rose M. Mayes from the Budget Engagement Commission Citywide Business seat, effective immediately. Ms. Mayes' term on the Commission expires on March 1, 2021.

On December 3, 2019, Budget Engagement Commissioners Ronaldo Fierro and Gaby Plascencia were officially sworn in as members of the City Council and so are stepping down from the Commission. Mr. Fierro's term expires on March 1, 2022, and Ms. Plascencia's term on the Commission expires on March 1, 2023.

On December 5, 2019, the City Clerk's Office received notification that Dawn C. McNulty of the Budget Engagement Commission Ward 7 seat no longer resides in the City. Ms. McNulty's term on the Commission expires on March 1, 2022.

Mayor Bailey recommends (a) redesignation of Jose R. Arballo from the Budget Engagement Commission Ward 2 Resident seat to the Citywide Resident seat for a term ending March 1, 2021; (b) appointment of Gary Montgomery to the Budget Engagement Commission Citywide Business seat for a term ending March 1, 2021, and (c) appointment of Aram Ayra to the Citywide seat on the Human Relations Commission for a term ending March 1, 2024.

The appointments, redesignation, and vacancies will be filled by registered voters in compliance with Charter requirements.

FISCAL IMPACT:

Recruitment and appointment costs are included annually in the City Clerk's budget.
