Following discussion and a report from the subcommittee on sanctions for violation of the Code of Ethics and Conduct, it was moved by Member House and seconded by Member Stahovich requesting the City Attorney to prepare an ordinance amending Riverside Municipal Code Chapter 2.78 Code of Ethics and Conduct to add sanctions for elected officials to include (1) public apology by the official to the complainant; (2) recommendation for training; (3) removal from regional committees; (4) removal from Mayor Pro Tem rotation; (5) public censure; and (6) restrict from traveling to attend meetings or conferences outside the City; and for appointed officials to include (1) public apology by the official to the complainant; (2) recommendation for training; (3) removal from Chair, Vice-Chair, or other leadership position; and (4) removal from the board or commission. Motion carried unanimously.
