During the development of the FY 2018-2020 Two-Year Budget, the Budget Engagement Commission (BEC) received numerous presentations and provided feedback to City departments on the spending priorities of the City. The presentations including the receipt of the Citywide proposed budget and individual department presentations on budgets under their purview.
