**BOARD OF PUBLIC UTILITIES INTERVIEWS** 

## **ISSUES**:

Interview applicants for the Community Police Review Commission, Planning Commission, and Board of Public Utilities.

#### **RECOMMENDATIONS:**

That the City Council:

- 1. Interview, reinterview, and appoint applicants to the Ward 3, 5, and 7 seats on the Community Police Review Commission for terms ending March 1, 2024;
- 2. Interview, reinterview, and appoint applicants to the Citywide and Ward 2 seats on the Board of Public Utilities for terms ending March 1, 2024;
- 3. Reinterview and redesignate applicant to the Ward 1 seat on the Board of Public Utilities for term ending March 1, 2024; and
- 4. Interview and appoint applicants to the Citywide and Ward 7 seats on the Planning Commission for terms ending March 1, 2024.

## **BACKGROUND/LEGISLATIVE HISTORY:**

Section XIV(A) of the City Council Rules of Procedure and Order of Business (Resolution No. 23035) provides that for vacancies on the Community Police Review Commission, Board of Ethics, Planning Commission, and Board of Public Utilities, the Mayor's Nominating and Screening Committee reviews applications submitted and identifies applicants for interview with the Mayor and City Council. The City Clerk notifies the Mayor and City Council of those selected for interview. The Mayor and each member of the City Council may add additional applicants for interview, if desired. The Mayor and City Council immediately vote on the appointments following the interviews. With a full quorum, five affirmative votes are required.

The Mayor's Nominating and Screening Committee met on December 17, 2019, with Chair Bailey and Members Melendrez and Conder present, and unanimously recommended that the City Council (1) interview (a) Bobby Hawkins, Eric J. Heaton, Michael D. Pope, and Todd Ridgway for the Ward 3 seat on the Community Police Review Commission; (b) Hector Echavarria, Andrew C. Woodard, Gina M. Gibson, David A. Rose, III, Warren Avery, and Andrew P. Villalobos for the

Citywide seat on the Planning Commission; (c) Christopher Allen and Evangelina Kaudza for the Ward 7 seat on the Planning Commission; and (d) Andrew C. Woodard, Phillip L. Rosentrater, Michelle R. Adams, and Mark S. Shirilau for a Citywide seat on the Board of Public Utilities for terms ending March 1, 2024; and (2) reinterview (a) Artemese C. Evans for the Ward 5 seat and David A. Huerta for the Ward 7 seat on the Community Police Review Commission; (b) Ana S. Miramontes for the Ward 2 seat on the Board of Public Utilities; and (c) David M. Crohn and redesignate to the Ward 1 seat on the Board of Public Utilities for terms ending March 1, 2024. Subsequently, Councilmember Edwards added Peter M. Wohlgemuth for interview for the Citywide seat on the Board of Public Utilities.
