PUBLIC COMMENT:

- After this meeting, Mike and Darrell need to set up and Ad-Hoc. Should be a Commission of the Deaf. The Clerk's Office provided some literature regarding the City Charter that needs to be reviewed and followed. Most of the committee members are from Ward 3. City Charter states you should have two members representing each Ward, but at least a minimum of one from each Ward. Where do most of the deaf community live, which Ward? Need to take a step back and create and Ad-Hoc Committee. Encouraged to go to additional Commissions meetings to see if there is a deaf person is present. If we start attending these meetings, the Commissions have never experienced having an interpreter present. We want to educate other Commissions.
- New Councilmember for Ward 3, Ronald Fierro, was supposed to attend this meeting as he is responsible for the MDCC.

APPROVAL OF MINUTES:

DISCUSSION ITEMS:

- Riverside TV First episode went well. Still need to work out logistics. Video is edited next door and is captioned. This is a trial and error period. Cheryl Wills stated you can view agenda and video on Engage Riverside web site. Video will also be posted on our MDC website.
- ADA Courthouse Systems we've met with representatives and now focus is on Family Court. Lisa is willing to join committee. The reason for replacement is Mike Anderson received two letters. Stephanie Martinez has resigned and plans to focus on family. She will volunteer when she can. The second one, AJ Reynoso has resigned because of the commute and to focus on school.
- By-Laws review if we are reducing our membership from 21 to 11, the By-Laws wording needs to be changed. That would be another Ad-Hoc Meeting.
- DeaFestival Slide missing. Festival is scheduled for September 19, 2020. Need more sponsors. Have two Co-Chairs, Alice Reynolds and Cindi Safford. Stephanie Martinez will write a note to previous sponsors to see if they will sponsor again this year.
- Deaf Community Center Darrell recaps that the task force has been established on a request from LA Club for the Deaf regarding a deaf community center. This center is for young people to senior citizens. Member of the community have been identified to participate, including the Riverside deaf seniors, California Home for the Adult Deaf, a representative from Codie and CSDR. The first meeting was in November, only a preliminary discussion to get a picture of what is needed and where it's needed. Need more surveys to determine, do we need a big/small building, who we are serving, etc. Next meeting will be in February. We are also presenting at Riverside Deaf Seniors event in March, the fourth Wednesday. Please reach out if you are interested in participating. David Reynolds advises that there is a lot of potential properties in Riverside. There is a large deaf community that continues to grow. Barbie Gomez states that sponsors are needed as this is an active fundraiser.
