SUBJECT: FIRST AMENDMENT TO MASTER PROFESSIONAL CONSULTANT SERVICES

AGREEMENT WITH MEAD & HUNT, INC. INCREASING TOTAL

COMPENSATION FROM \$250,000 TO \$500,000

ISSUES:

Approve the First Amendment to Master Professional Consultant Services Agreement with Mead & Hunt, Inc. increasing total compensation from \$250,000 to \$500,000.

RECOMMENDATION:

That the City Council:

- 1. Approve the First Amendment to the Master Professional Consultant Services Agreement with Mead & Hunt, Inc., increasing total compensation from \$250,000 to \$500,000; and
- Authorize the City Manager, or his designee, to execute the First Amendment to the Master Professional Consultant Services Agreement, including making minor and non-substantive changes.

BACKGROUND:

On October 21, 2016, the Riverside Municipal Airport (Airport) issued Request for Proposals No. 1650 for a consultant to provide on-call design and construction management services for projects to improve and maintain the Airport to Federal Aviation Administration (FAA) design standards.

On February 13, 2017, the City Council approved a five-year Master Professional Consultant Services Agreement for Mead & Hunt, Inc. through February 2022 to provide on-call design and construction management services at Riverside Municipal Airport. The Agreement includes a total compensation amount of \$250,000 over the term of the Agreement.

Projects completed under the Agreement through December 2019 include the following:

DISCUSSION:

Staff meets with the FAA annually to review and discuss the five-year Airport Capital Improvement Plan (ACIP) proposal for the Airport. The five-year Master Professional Consultant Services Agreement for Mead & Hunt, Inc. in the amount of \$250,000 was developed based on the 2017 ACIP plan proposed in December 2016.

Due to changes in annual federal funding, the FAA required the Airport to modify planned projects identified in the 2017 ACIP, adding projects that require consultant services. The anticipated increase in services expected to be received from Mead & Hunt, Inc. over the remaining term of the Agreement is estimated at \$223,000. Projects anticipated to be completed through the remaining term of the Agreement include:

Total Estimated Services

Consultant expenditures for projects eligible for federal grants are reimbursed at a rate of 90% of the project costs by the FAA and 5% of the Federal project contribution by the State of California, Department of Transportation grants. Anticipated reimbursement for current projects is estimated at \$210,735.

Purchasing Resolution No.23256, Section 702 (g) states "When services can be procured from a contractor who offers the same or better price, terms and conditions as the contractor previously offered as the lowest responsive bidder under competitive procurement or negotiations conducted by the City or another public agency, provided that, in the opinion of the Manager, it is in the best interests of the City to do so."

The Purchasing Manager concurs that this Purchase is in compliance with Purchasing Resolution 23256, Section 702 (g).

FISCAL IMPACT:

The cost of this action is up to \$250,000 dependent on Federal grant award(s), with a potential City match requirement of \$27,500 in future fiscal years. Sufficient funds are available in the Airport Fund (530) and will be appropriated as part of the Fiscal Year 2020-2022 Two Year Budget.
