CALL TO ORDER

The meeting was called to order at 5:00 p.m. by Vice President Goldware.

Consent calendar item 5 was pulled by Trustee Evans for further discussion.

Trustee Evans inquired if the number of incidents were increasing. Library Director Christmas responded that there were 380 incidents last year and anticipates this year there will be approximately 690 based on current numbers. The Library Department will be providing a presentation to the Budget Engagement Commission on February 13 requesting funding for safety measure that include additional security guards, security cameras and panic buttons. Also, Deputy City Manager Moises Lopez will be providing a presentation today on the homelessness issue.

Trustee House asked if there was a plan for the number of day so exclusions on the exclusion policy. Library Director Christmas indicated the exclusions issued are determined by the number of incidents, then by severity that dictate the number of days of exclusion such as 30, 60, or 90 days and up to a year. The exclusion notices follow a fair process. Additionally, the policy will be amended by the City Attorney's office in late summer to coincide with City Municipal Code and will be presented to the Board for consideration.

Trustee House inquired if police were notified on more serious issues and what was the number of days for such exclusion. Library Director Christmas indicated that 180 days of exclusion are typically issued for police interaction.

Trustee Tate requested if the incident report could be notated when the police are notified.

Trustee Evans asked if the increase in incidents a trend across the state and Library Director Christmas are replied yes.

Following discussion, the incident report was approved.
