SUBJECT: MEASURE Z – SUPPLEMENTAL APPROPRIATION IN THE AMOUNT OF \$951,377 FOR PURCHASE AND INSTALLATION OF PANIC BUTTONS, SECURITY CAMERAS AND ADDITIONAL SECURITY GUARD SERVICES AT VARIOUS RIVERSIDE PUBLIC LIBRARY FACILITIES FOR FISCAL YEARS 2019-2022 – SUPPLEMENTAL APPROPRIATION

ISSUE:

Authorize a supplemental appropriation in the amount of \$951,377 from the unallocated Measure Z fund balance to fund operating costs for purchase and installation of panic buttons, security cameras and additional security guard services at various Riverside Public Library Facilities for fiscal years 2019-2022.

RECOMMENDATIONS:

That the City Council:

- 1. Approve a supplemental appropriation in the amount of \$951,377 from the unallocated Measure Z fund balance to fund operating costs for purchase and installation of panic buttons, security cameras and additional security guard services at various Riverside Public Library Facilities for fiscal years 2019 through 2022; and
- 2. Authorize the City Manager, or designee, to execute all documents pursuant to these purchases, and to make minor non-substantive changes.

BUDGET ENGAGEMENT COMMISSION RECOMMENDATION:

On February 13, 2020, the Budget Engagement Commission, with 10 members present, voted unanimously to recommend that the City Council approve a supplemental appropriation in the amount of \$951,377 from unallocated Measure Z fund balance to fund operating costs for additional security guard services, purchase and installation of panic buttons and security cameras at various Riverside Public Library facilities for fiscal years 2019 through 2022.

BACKGROUND:

On June 13, 2019, the Budget Engagement Commission recommended to the City Council to


approve a supplemental appropriation of \$122,000 from the unallocated Measure Z fund balance to fund operating costs for additional unarmed security guard services at various Riverside Public Library facilities. The current budgeted amount for security guard services is \$160,646 from the General Fund and \$122,000 allocated from the Measure Z fund for Fiscal Year (FY) 2019/20 for a total budgeted amount of \$282,645 for security guard services. Funding in future budget cycles was not identified in the Library's budget.

On June 18, 2019, the City Council approved a resolution adopting the amended FY 2019/20 Budget to include the supplemental appropriation of unallocated Measure Z funds in the amount of \$122,000.

DISCUSSION:

The Riverside Public Library has established Rules of Library Conduct (adopted by the Board of Library Trustees on September 20, 1982 and amended February 27, 2017) for successful running of its facilities, to maintain an appropriate library environment, and to ensure customers enjoy their Library visits. Library employees, in consultation with their supervisor, are authorized to issue warning and exclusion notices and the incidents are reported to the Board of Library Trustees at their regularly scheduled meetings. The incident reports are available on the city's agenda website at https://riversideca.legistar.com/Calendar.aspx. Staff monitor the incidents reported and prepared a 4-year comparison for reference.

The 4-year comparison in the chart below reflects a 91% increase in incidents reported in FY 2018/19 from the prior year. With 385 incidents reported from July through January for FY 2019/20 the Library is projected to have approximately 770 incidents. The incidents are not only increasing in quantity but also in severity of infractions. For example, some individuals in the Library have been excluded for assaulting, threatening and harassing staff or Library customers, brandishing weapons, public intoxication, etc. There is also evidence each morning of incidents throughout the evening at the Main Library including alcohol and drug paraphernalia, significant trash and debris, etc.



Staff have determined that the presence of additional unarmed security guard services, panic buttons and additional security cameras would allow the Riverside Public Library to continue providing a positive library environment and to achieve its goal in creating a safe and welcoming public space. The following categories for security guard services, panic buttons and security cameras provide further detail.

Category: Security Guard Services

Unarmed security guard services for FY 2019/20 are provided at the following library facilities with funding from the General Fund in the amount of \$160,646 and Measure Z funds in the amount of \$122,000; a total amount of \$282,645 allocated for security guard services:

- 1. Arlanza Library (part-time)
- 2. Arlington Library (full-time)
- 3. Main Library (full-time and evening external patrol)
- 4. Marcy Library (part-time)
- 5. La Sierra Library (full-time and evening external patrol)
- 6. SPC Jesus S. Duran Eastside Library (full-time)

Due to the unforeseen increase in incidents at the Library facilities, funding for additional security guard services is being requested for additional services and to maintain unarmed security guard services at the following facilities.

- 1. Arlanza (add 1 full-time guard and remove part-time)
- 2. Arlington (maintain 1 full-time guard and add evening external patrol)
- 3. Main (add 24-hour guard service and maintain 1 full-time guard)
- 4. Marcy (add 1 full-time guard and remove part-time)
- 5. La Sierra (maintain 1 full-time guard and evening external patrol)
- 6. SPC Jesus S. Duran Eastside Library (maintain 1 full-time guard)

* Security Guard services would be increased in FY 2019/20 in addition to increases implemented with the previously approved supplemental appropriation of Measure Z funds.

Category: Panic Buttons

Panic buttons are usually placed in a discreet location such as under a desk and are a hardwired or wireless device that can assist staff in alerting the police to an emergency. No library facilities currently have this device. The cost is estimated at \$36,950 and is provided in the following table. The annual monitoring rate of \$1,656 will be absorbed in the Library Departments operating budget.

Category: Security Cameras

Additional security cameras may deter crime and provide protection or useful surveillance footage to police officers during a crime. Most library facilities have security camera coverage, however La Sierra and SPC Jesus S. Duran Eastside Library have inadequate camera coverage. The estimated cost per security camera and installation is \$3,000 to \$5,000 and is outlined in the table below.

FISCAL IMPACT:

The total fiscal impact for FY 2019/2022 of the recommended action is \$951,377, as shown in the table below.

Sufficient funding is available in the Measure Z unallocated fund balance for this item. Currently, Measure Z is projected to end FY 2019/20 with an unallocated fund balance of approximately \$16.3 million (Attachment 1). If the full allocation toward Library security of \$951,377 is approved for FYs 2019 through 2022, Measure Z is projected to end FY 2021/22 with an unallocated fund balance of approximately \$30.2 million.

Upon City Council approval, an increase in appropriations will be made to the Library Neighborhoods Services Professional Services expenditure account 8004002-421000.
