3	AN ORDINANCE OF THE CITY OF RIVERSIDE, CALIFORNIA, AMENDING SECTION 4.05.050 OF THE
4	RIVERSIDE MUNICIPAL CODE - PUBLIC MEETINGS AND PUBLIC RECORDS.

6	The City Council of the City of Riverside does ordain as follows:
7	<u>Section 1</u> : Section $4.05.050(D)(2)$ of the Riverside Municipal Code is hereby
8	amended to read as follows:
9	"4.05.050(D) Excuse of Sunshine Notice Requirements.
10	•••
11	(2) If the Mayor or a Council Member, with the concurrence of two other Council
12	Members, believes an item is urgent, which urgency is detailed, in writing, in the Council
13	Report, and the failure to meet any additional notice requirements was due to:
14	(a) The need to take immediate action, which came to the attention of the local body
15	after the agenda was posted, or;
16	(b) A software or hardware impairment as defined by Section 4.05.010.H and such
17	additional notice requirements are satisfied no later than 72 hours before the date of the meeting;
18	or,"
19	Section 2: The City Council has reviewed the matter and, based upon the facts and
20	information contained in the staff reports, administrative record, and written and oral testimony,
21	hereby finds that this ordinance is not subject to CEQA pursuant to Sections 15060(c)(2),
22	15060(c)(3) and/or 15061(b)(3) of the State CEQA Guidelines, California Code of Regulations,
23	Title 14, Chapter 3, in that it will not result in a direct or reasonably foreseeable indirect physical
24	change in the environment nor have a significant impact on the environment.
25	Section 3: The City Clerk shall certify to the adoption of this ordinance and cause
26	publication once in a newspaper of general circulation in accordance with Section 414 of the
27	Charter of the City of Riverside. This ordinance shall become effective on the 30th day after the
28	date of its adoption.
