Ms. Nicol, Thank you so much for your response - and on a Sunday! I really appreciate your assistance.

Council Members - seriously? Now we're being relegated to "drive-through" comments? I understand the situation regarding Covid-19 and its attendant protocols. What I don't understand is WHY this is being pushed through in such a hurry, and under such circumstances.

Will Kyle and the developer's team be relegated to the parking lot as well? If not, why not? We have as much right to be heard in person as they do.

I'd also like to address the letters you have received (from the meeting agenda attachments) - please note that the letters AGAINST the project are from the neighbors who actually live in close proximity to the project, and the majority of the letters FOR the project are from people who do not live IN the neighborhood and in some cases are from agencies that are in the business of supporting homeless solutions. And while that's admirable, they get PAID to advocate for these types of projects...and DON'T have to deal with the results on a daily basis!

Also attached to the agenda are the petitions both for and against. I took the time to read through these - here's what I found: the number of signatures AGAINST the project is 210 (these were from a meeting a few weeks ago - who knows where the original petitions are that were signed several years ago?). The number of signatures FOR (and these signatures are dated **several years ago**) is 119...and MANY of them are from addresses and ZIP codes nowhere near St. Michaels. Again, if they don't live here, WHY SHOULD THEIR OPINION MATTER???

Lastly, one of the concerns the Planning Commission had was the traffic issue. The city traffic engineer showed you pictures of empty streets, saying they had sat on our streets for a day and took pictures and look - no cars! There shouldn't be a problem! But what he didn't say was that they did their study on a Wednesday...which in our tract is street sweeping day. Yep - there's a reason there were no cars on the street! I'm attaching pictures I took on Saturday, February 15th. You'll notice that there ARE cars - and this is the norm. Now add 100 parking spaces (spaces=cars), and tell us there shouldn't be any issues with parking.

There's so much more I'd like to add - like, what's up with the separation of church and state, or doesn't it matter to Riverside? And what about the great point brought up about the variances that were approved back in the 1960s and are being still used to allow this monstrous structure...pretty sure that's not what they expected to happen in 2020...oh, and how impressed I was with your action on Ms. Edward's request for a building moratorium in the northside area of Riverside - all of you said wonderful things about the residents and how they aren't any less deserving than any other Riverside residents (Ms. Plascencia). Mr. Fierro was impressed with the unanimity of the residents and said that since the community would be impacted negatively he was in favor of the moratorium.

Let me end with one more plea to just stop. Stop this project from going forward as requested. Make it smaller, a better fit for the neighborhood. Why should we be any less deserving than the residents of the Northside, Gaby? Listen to YOUR community, please. Vote NO on the appeal.








They have nurses in and out of her home. The church is hosting AA type meetings (stopped last week) and people smoke outside. The wind blows towards her home. The smell bothers her. She is concerned about the size of the project. She is concerned the smoke is a danger to her husband's health. She does not feel safe with the homeless traffic in her neighborhood. There was somebody standing on her side-walk and she did not feel safe. Somebody walked into her home unauthorized. She called the police and the police officer came and responded, "that is the way they are". She does not feel safe. Police have no authority when people are walking into their yards. Somebody removed opposition signs from their yard. I read her this email to ensure it captures her concerns and she agrees. I am also going to mail her a copy so she will know it has been submitted on her behalf. In our call she identified the need for some cleaning supplies (Lysol and disinfectant). I will drop those by to her tomorrow sometime.
