#### **BOTTOM LINE UP FRONT**

- The Office of the Mayor has raised \$72,543.83 in total donations to offset the cost of 20 emergency sleeping cabins,
- In addition, we have generated an additional \$1,135,237.64 in revenue via a direct allocation to the city as a result of our membership in the Big City Mayors group
- The Emergency Sleeping Cabin community was designed with 30 Emergency Sleeping Cabins, 10 of which are on loan until May 1, 2020 by the vendor.

- In light of this recent change in direction from congregant to non-congregant shelter, and in light of the winter months ending, returning the 10 cabin shelters will be counterproductive to the City's and State's efforts to address homelessness.
- Moving residents out of emergency sleeping cabins during a pandemic poses a sizable public risk to the city.

## **RECOMMENDATIONS (CONT.)**

- 3. Authorize the use of 2019-2020 Homeless Housing, Assistance and Prevention Program funding to refund the remaining emergency sleeping cabins cost of \$68,469.46 for 20 emergency sleeping cabins purchased with Measure Z funding.
- 4. Authorize the use of Homeless Housing, Assistance and Prevention Program funding to purchase the 10 emergency sleeping cabins on loan in an amount not to exceed \$58,930.00
