SIDEWALK AND MOBILE VENDOR REGULATIONS

Following discussion and without formal motion, the City Council requested staff to prepare an ordinance for City Council consideration amending Chapter 5.38 of the Riverside Municipal Code regarding sidewalk vendors to comply with State law.

BID 7696 - IOWA AVENUE IMPROVEMENTS - REIMBURSEMENT AGREEMENT - SUPPLEMENTAL APPROPRIATIONS - FUNDS TRANSFER

Following discussion, it was moved by Councilmember Melendrez and seconded by Councilmember Conder to (1) award Bid 7696 for Iowa Avenue improvements from Martin Luther King Boulevard to University Avenue to H&H General Contractors, Inc., of Highland, California, in the amount of \$4,769,690; (2) authorize 10% change order authority in the amount of \$476,969 for project changes due to unforeseen conditions for a total project cost not-to-exceed \$5,246,659; (3) authorize the City Manager, or his designee, to execute the construction contract with H&H General Contractors, Inc., including making minor non-substantive changes; (4) approve a reimbursement agreement with Western Riverside Council of Governments in the amount of \$2,920,000 in Transportation Uniform Mitigation Fee funds; (5) authorize the City Manager, or his designee, to execute the reimbursement agreement with Western Riverside Council of Governments, including making minor and non-substantive changes; (6) authorize a supplemental appropriation in the amount of \$2,920,000 in Transportation Uniform Mitigation Fee funds to the Iowa Avenue Improvements project account and increase the estimated revenue by the same amount; (7) authorize a supplemental appropriation in the amount of \$350,000 from the Measure A Fund Balance to the Iowa Avenue Improvements project account; and (8) authorize a supplemental appropriation and funds transfer in the amount of \$500,000 from a special deposit account for the adjacent California Air Resources Board development to the Iowa Avenue Improvements project account and increase the estimated revenue by the same amount. The motion carried with all ayes and Councilmember Perry absent.

The public hearing was officially closed. Following discussion, it was moved by Councilmember Melendrez and seconded by Councilmember Conder to (1) adopt a resolution amending the applicable TUMF for all development in the City of Riverside; and (2) request Western Riverside Council of Governments to consider delaying fee increases until the COVID-19 impacts are fully determined. Whereupon, the title having been read and further reading waived, Resolution No. 23561 of the City Council of the City of Riverside, California, Amending the Applicable Transportation Uniform Mitigation Fee (TUMF) Applicable to All Development in the City of Riverside, was presented and adopted.

CASE P18-0208 - CITY OF RIVERSIDE - LA SIERRA UNIVERSITY SPECIFIC PLAN AMENDMENT - RESOLUTION - PIERCE/RIVERWALK PARKWAY/LA SIERRA

Hearing was called to consider an amendment to the La Sierra University Specific Plan to achieve consistency with existing General Plan Land Use and Zoning designations established pursuant to the 5th Cycle Housing Element Rezoning Program and to designate LSUSP Subarea 11 (approximately 5 acres) from "Commercial" to "Multi-Family Residential (29 du/ac)" and LSUSP Subarea 12 (approximately 1.6 acres) from "Commercial" to "Mixed-Use Village" on property located on the southeast corner of Pierce Street and Riverwalk Parkway (Subarea 11) and the south side of Pierce Street west of La Sierra Avenue (Subarea 12). The public hearing was officially closed. Following discussion, it was moved by Councilmember Plascencia and seconded by Councilmember Fierro to (1) determine that Planning Case P18-0208 Specific Plan Amendment is consistent with Implementation Program Tool H-21 (Rezoning Program) analyzed within the Final Program Environmental Impact Report for the 2014-2021 Housing Element Implementation Program, certified December 12, 2017, and further determine that the project is exempt from the California Environmental Quality Act pursuant to Section 15061(b)(3) as it can be seen with certainty that there is no possibility that this proposal will have a significant effect on the environment; (2) approve Planning Case P18-0208 Specific Plan Amendment based on the findings set forth in the case record and outlined in the Planning Commission staff report; and (3) adopt a Resolution amending the La Sierra University Specific Plan changing the Specific Plan Land Use Designation of approximately 6.6 acres to HDR - High-Density Residential and MU-V -Mixed Use - Village. The motion carried with all ayes, Councilmember Perry absent, and Councilmember Hemenway disqualified.

AGREEMENT - MULTI-SPACE PAY STATIONS - SUPPLEMENTAL APPROPRIATION

The City Council (1) approved a Professional Consultant Services Agreement (Technology Services) from Request for Proposal No. 1792 with IPS Group, Inc., of San Diego, California, for 79 multi-space pay station units in the amount of \$650,649 for a five-year term and two additional two-year extension options; (2) authorized a supplemental appropriation in the amount of \$650,649 from the Public Parking Fund to the Multi-Space Pay Stations account; and (3) authorized the City Manager, or his designee, to execute the Professional Consultant Services Agreement (Technology Services) with IPS Group, Inc., including making minor and non-substantive changes and the optional two two-year terms.

LEASE AGREEMENT - 2801 HULEN PLACE

The City Council (1) approved the Lease Agreement with Helping Hearts Hulen, LLC, for approximately 4,700 square feet of the City-owned building located at 2801 Hulen Place for \$1 annually to operate a transitional mental health program for a five-year term; and (2) authorized the City Manager, or his designee, to execute the Lease Agreement including making minor non-substantive changes and the two optional five-year renewals, and to sign all documents and instruments necessary to complete the transaction.

AGREEMENT AMENDMENT - TEMPORARY EMPLOYMENT SERVICES

The City Council (1) approved the Fifth Amendment to Professional Consultant Services Agreement with CSG Consultants, Inc., for temporary employment service needs of the Building and Safety Division for an additional two-year term through June 30, 2022, in the amount of \$100,000 annually for a total contract amount of \$740,000 in accordance with Purchasing Resolution No. 23256, Section 702(g); and (2) authorized the City Manager or his designee to execute the Fifth Amendment to Professional Services Agreement with CSG Consultants, Inc., including making minor and non-substantive changes.

CASE P19-0487 - CULTURAL HERITAGE BOARD SUBCOMMITTEE SCHEDULE MODIFICATION - 4674 BEACON WAY

The City Council approved modifications to extend the schedule related to Planning Case P19-0487 Certificate of Appropriateness for the Cultural Heritage Board to (1) form a sub-committee to work with the applicant on design modifications from March 2020 to May 2020; and (2) take a final action on the Certificate of Appropriateness from May 2020 to July 2020.

FISCAL YEAR 2019-20 SECOND QUARTER FINANCIAL REPORT AND MEASURE Z UPDATE - INTERFUND TRANSFERS - SUPPLEMENTAL APPROPRIATIONS

The City Council (1) received and ordered filed the Fiscal Year 2019/20 Second Quarter Financial Report and Measure Z update; (2) approved an interfund transfer of \$9,353,990 from the General Fund to the Pension Stabilization Fund, representative of the amount previously approved for investment in the Section 115 Pension Trust; (3) approved an interfund transfer of \$23,000 from the Electric Fund to the General Fund to reimburse the General Fund for a prior year accounting error; (4) approved an increase in revenues of \$200,000 and a supplemental appropriation of \$200,000 in the General Fund Innovation & Technology Department for critical technology needs; (5) eliminated a budgeted transfer of costs in the amount of \$189,046 from General Fund Fire Prevention to the Grants and Restricted Programs Fund, Certified Unified Program Agency account, effectively increasing General Fund appropriations; and (6) approved a supplemental

BID 7720 - COMPRESSED NATURAL GAS STORAGE SPHERES - 5961 ACORN STREET The City Council awarded Bid 7720 to Allied Equipment, Inc., of Odessa, TX, in the amount of \$115,275 for purchase and delivery of four additional Compressed Natural Gas storage spheres to be located at the Acorn Street Compressed Natural Gas Fueling Station located at 5961 Acorn Street.

The City Council approved the recommendations of Mayor Bailey to (1) accept monetary donations in the amount of \$72,543.83 and any future private donations to reimburse the City for purchase of twenty emergency sleeping cabins; (2) authorize an increase in revenue in the amount of \$72,543.83 to the Pallet Shelter Fund account and appropriate expenditures in the same amount to an expenditure account; (3) authorize use of 2019-2020 Homeless Housing, Assistance and Prevention Program funding to refund the remaining emergency sleeping cabins cost of \$68,469.46 for twenty emergency sleeping cabins purchased with Measure Z funding; and (4) authorize use of Homeless Housing, Assistance and Prevention Program funding to purchase the ten emergency sleeping cabins on loan in an amount not-to-exceed \$58,930.

AGREEMENT AMENDMENT - SANTA ANA TRUNK SEWER REPLACEMENT PROJECT

The City Council (1) approved the Third Amendment to Supplemental Agreement for the Santa Ana Trunk Sewer Replacement Project with ECORP Consulting, Inc., to increase compensation by an additional \$71,637 (10%) for a total amount of \$788,009.60 for weed abatement, replanting of trees and plants, replacement of fences and signs due to vandalism, and a water truck for irrigation; and (2) authorized the City Manager, or his designee, to execute the Third Amendment to Supplemental Agreement with ECORP Consulting, Inc., including making minor non-substantive changes.

CHANGE ORDER AUTHORITY - LANDSCAPE MAINTENANCE SERVICES

The City Council authorized additional change order authority with Mariposa Landscapes, Inc., of Irwindale, CA, to provide landscape maintenance services throughout south quadrant parkways and medians in the amount of \$147,500 for the period of July 1, 2019, to June 30, 2021, for a revised total contract amount of \$3,801,456.20.

The motion carried with all ayes and Councilmember Perry absent.

PROTECTIONS FOR ESSENTIAL WORKERS - RESOLUTION

Following discussion, it was moved by Councilmember Fierro and seconded by Councilmember Plascencia to approve the recommendations of Councilmember Fierro and Councilwoman Plascencia to adopt a resolution providing COVID-19 protections for both essential workers and the general public for the duration of the local emergency by (1) ordering grocery and pharmacy retail stores to (a) limit the occupancy of persons at any given time to 50% of capacity; (b) enforce social distancing requirements by marking down the floors inside and outside stores with indicators as well as posted signs to remind customers and employees of six-foot social distancing requirements; (c) provide non-

medical face masks and gloves for employees at the expense of the employer and allow employees to wash hands as needed; (d) install Plexiglas shields at all points of sale whenever possible; (e) maintain security onsite to enforce social distancing measures and safeguard employees from unruly customers; and (f) inform employees of precautions employer will take when an employee tests positive for COVID-19 and to the best of the employer's ability inform affected employees without violating HIPPA when a co-worker within a store tests positive for COVID-19; and (2) strongly encouraging all essential businesses including grocery and convenience stores to utilize their ability to refuse service to customers not wearing face masks. The motion carried with all ayes, Councilmember Perry absent, and Councilmember Conder not voting.

Whereupon, Resolution No. 23569 of the City Council of the City of Riverside, California, Establishing Temporary Grocery, Pharmacy Retail Worker Protections for the Duration of the Local Emergency, was presented and adopted.
